ROAD TRAFFIC REGULATION ACT 1984**

**BRIGHTON & HOVE (WAITING & LOADING/UNLOADING RESTRICTIONS AND
PARKING PLACES) CONSOLIDATION ORDER 2008 AMENDMENT ORDER No.3 2012**

Brighton & Hove City Council in exercise of its powers under Sections 1, 2, 3, 4, 19, 32, 35, 35A, 43, 44, 45, 46, 46A, 47, 49, 51, 53, 55, 61, 63, 63A, 66, 117 and 124 (1) (c) & (d) to the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the above named Order.

The provisions of this Order will come into operation on the *1st* day of *April* 2012 and amend the Brighton & Hove (Waiting & Loading/Unloading Restrictions and Parking Places) Consolidation Order 2008 as follows:

ARTICLE AMENDMENTS:

PART 1 – GENERAL

In Article 3:

Delete the paragraph commencing "**Administration Charge**"

In the paragraph commencing "**Dispensation**" delete "Schedule 2" and substitute "Schedule 2 Part 1"

In the paragraph commencing "**Waiver**" delete "Schedule 2" and substitute "Schedule 2 Part 1"

PART 4 – PARKING PERMITS

PART 4.1 – General

In Article 3 delete "Schedule 2" and substitute "Schedule 2 Part 1".

In Article 5 after the words "requisite documentation" insert the words "and any payment required".

PART 5 – SUSPENSIONS

In Article 2 delete "Schedule 2" and substitute "Schedule 2 Part 1a".

PART 9 - LIST OF SCHEDULES

Delete "Charges and Tariffs" and substitute "Charges and Fees"

Below "Schedule 2: Charges and Fees" insert the following:

Delete existing Schedule 2 in its entirety and substitute a new Schedule and Parts as follows:
