**BRIGHTON & HOVE (WAITING & LOADING/UNLOADING RESTRICTIONS
AND PARKING PLACES) CONSOLIDATION ORDER 2008 AMENDMENT
ORDER No.8 2012
(ST MARTIN'S STREET & TRINITY STREET)**

Brighton & Hove City Council in exercise of its powers under Sections 1, 2, 3, 4, 19, 32, 35, 35A, 43, 44, 45, 46, 46A, 47, 49, 51, 53, 55, 61, 63, 63A, 66, 117 and 124 (1) (c) & (d) to the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the above named Order.

The provisions of this Order will come into operation on the *20th* day of *April* 2012 and amend the Brighton & Hove (Waiting & Loading/Unloading Restrictions and Parking Places) Consolidation Order 2008 as follows:

SCHEDULE 1 AMENDMENTS:

Part I.1 No Waiting At Any Time

Amend item Ref. no.2319 (St Martin's Street) as follows:

Delete "9 metres" and substitute "11 metres"

Amend item Ref. no.2789 (Trinity Street) as follows:

Delete "Both" and substitute "North-east"

Add new item as follows:

Ref. no.	Road Name	Side	Description
2789a	Trinity Street	South -west	From the north-western kerbline of Lewes Road north westwards for 6.5 metres

Part II.2 Loading bay 8am to 6pm every day

Add new item as follows:


Ref. no.	Road Name	Side	Description
3c	Trinity Street	South -west	From a point 13.8 metres north-west of the north-western kerbline of Lewes Road north-westwards for a distance of 8 metres

Part 16.1 Pedal Cycle Parking Places At Any Time

Add new items as follows:

Ref. no.	Road Name	Side	Description
8	St Martin's Street	North-east	From a point 11 metres north-west of the north-western kerbline of Lewes Road north-westwards for a distance of 7.8 metres
9	Trinity Street	South-west	From a point 6.5 metres north-west of the north-western kerbline of Lewes Road north-westwards for a distance of 7.3 metres
