

**BRIGHTON & HOVE CITY COUNCIL  
ROAD TRAFFIC REGULATION ACT 1984**

**BRIGHTON & HOVE SEAFRONT (VARIOUS RESTRICTIONS)  
CONSOLIDATION ORDER 2008 AMENDMENT ORDER No.5 2012**

Brighton & Hove City Council in exercise of its powers under Sections 1, 2, 3, 4, 19, 32, 35, 35A, 43, 44, 45, 46, 46A, 47, 49, 51, 53, 55, 61, 63, 63A, 66, 117 and 124 (1) (c) & (d) of the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the above named Order.

The provisions of this Order will come into operation on the <sup>1<sup>st</sup></sup> day of ~~November~~ 2012 and amend the Brighton & Hove Seafront (Various Restrictions) Consolidation Order 2008, as amended, as follows:-

**SCHEDULE 1 AMENDMENTS:**

**Part 3.1 Pay and Display Parking Places – Monday to Sunday 9.00am to 6.00pm**

Add new item 27: Madeira Drive – North Side - 1.8 metres wide from a point 372.5 metres east of the eastern side of the Palace Pier forecourt eastwards for a distance of 33 metres. (5 bays)

**Part 5.1 Disabled Badge Holders Parking Places 24 hours of any day**

Delete item 8 Marine Parade, Brighton

Amend item 9 Marine Parade: delete "5 metres" and substitute "11 metres"

Amend item 11 New Steine: insert after west side "(western arm)" delete "5.65 metres" and substitute "11 metres"

Delete item 12 New Steine, Brighton

**Part 6.1 Motorcycles Parking Places 24 hours of any day**

Renumber existing item 1 Kingsway as item 4

Add new item 1: Grand Junction Road – South side – From a point 7 metres east of a prolongation of the eastern kerbline of Brills Lane, eastwards for a distance of 14.5 metres

Renumber existing item 2 Kingsway as item 5

Add new item 2: Kings Road – South side – Extending from a point 46 metres west of a prolongation of the western kerbline of the western carriageway of Bedford Square westwards for a distance of 6.5 metres

Add new item 6: Madeira Drive – South side – From a point 725 metres east of a prolongation of the eastern side of the Palace Pier forecourt eastwards for a distance of 4 metres

Add new item 7: Madeira Drive – North side – From a point 336 metres east of a prolongation of the eastern side of the Palace Pier forecourt eastwards for a distance of 30.8 metres

Add new item 8: Madeira Drive – North side – From a point 825 metres east of a prolongation of the eastern side of the Palace Pier forecourt eastwards for a distance of 3 metres

Add new item 9: Madeira Drive – North side – From a point 959 metres east of a prolongation of the eastern side of the Palace Pier forecourt eastwards for a distance of 8 metres

Add new item 10: Madeira Drive – North side – From a point 1031 metres east of the eastern side of the Palace Pier forecourt eastwards for a distance of 7 metres

Add new item 11: Marine Parade – South side – From a point 1 metre east of a prolongation of the eastern kerbline of Camelford Street eastwards for a distance of 5 metres

Add new item 12: Marine Parade – South side – From a point 82.5 metres east of a prolongation of the eastern kerbline of Madeira Place eastwards for a distance of 5 metres

Add new item 13: New Steine – East side (Western carriageway) – From a point 6 metres north of the northern kerbline of Marine Parade northwards for a distance of 4.5 metres

Add new item 14: New Steine – West Side (Eastern carriageway) – From a point 4.5 metres south of the southern kerbline of St James's Street southwards for a distance of 5.5 metres

**Part 6.2 Solo Motorcycles Parking Bay Monday to Sunday 9am to 6pm**  
Delete this Part of the Schedule in its entirety

**Part 7.2 Loading Only 24 hours Monday to Sunday limited to 30 minutes with no return within 1 hour**

Add new item 1a: King's Road – South side – From a point 9.5 metres west of the prolongation of the western kerbline of the eastern arm of Bedford Square westwards for a distance of 19.6 metres
