**BRIGHTON & HOVE (WAITING & LOADING/UNLOADING RESTRICTIONS
AND PARKING PLACES) CONSOLIDATION ORDER 2008 AMENDMENT
ORDER NO.17 2012**

Brighton & Hove City Council in exercise of its powers under Sections 1, 2, 3, 4, 19, 32, 35, 35A, 43, 44, 45, 46, 46A, 47, 49, 51, 53, 55, 61, 63, 63A, 66, 117 and 124 (1) (c) & (d) of the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the above named Order.

The provisions of this Order will come into operation on the *9th* day of *November* 2012 and amend the Brighton & Hove (Waiting & Loading/Unloading Restrictions and Parking Places) Consolidation Order 2008 as follows:

Part 1.1 No Waiting At Any Time

Amend item Ref.no.19 Albion Hill: in the column headed "Side" delete "Both" and substitute "North".

Delete existing items Ref.nos.25, 26, 27, 27c, 27d, 27e, 27f and 27g (Albion Hill)

Insert new items as follows:

Ref. no.	Road Name	Side	Description
27c	Albion Hill	South	From the eastern kerbline of Albion Street eastwards to the western kerbline of Grove Hill
27d	Albion Hill	South	From the eastern kerbline of Grove Hill south-eastwards to the western kerbline of the private road opposite Newark Place
27e	Albion Hill	South	From the eastern kerbline of the private road opposite Newark Place south-eastwards to the western kerbline of John Street
27f	Albion Hill	South	From the eastern kerbline of John Street south-eastwards to the western kerbline of the private road opposite Grove Street
27g	Albion Hill	South	From the eastern kerbline of the private road opposite Grove Street to a point 8 metres south-east of a prolongation of the south-eastern kerbline of Grove Street

Delete existing item 2146 Queen's Park Road and substitute the following:

Ref. no.	Road Name	Side	Description
2146	Queen's Park Road	North-west	From the northern kerbline of Albion Hill north-eastwards to the southern kerbline of Islingword Road
2146a	Queen's Park Road	South-east	From the northern kerbline of Albion Hill north-eastwards to the southern kerbline of Queen's Park Terrace

Delete existing item 2153 Queen's Park Road

Delete existing items 2154 and 2156 Queen's Park Road and substitute the following:

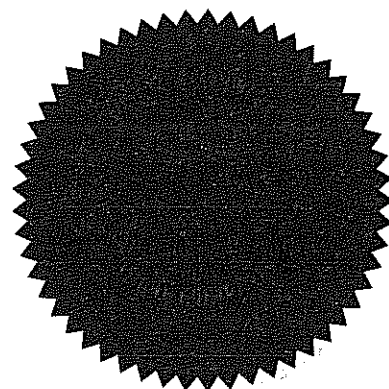
Ref. no.	Road Name	Side	Description
2154	Queen's Park Road	North-west	From the southern kerbline of Islingword Road south-westwards for a distance of 29 metres.
2156	Queen's Park Road	North-west	From the northern kerbline of Albion Hill north-eastwards for a distance of 13.7 metres.

Delete existing item 2157 Queen's Park Road
