# BRIGHTON & HOVE (WAITING & LOADING/UNLOADING RESTRICTIONS AND PARKING PLACES) CONSOLIDATION ORDER 2008 AMENDMENT ORDER No.3 2013

Brighton & Hove City Council in exercise of its powers under Sections 1, 2, 3, 4, 19, 32, 35, 35A, 43, 44, 45, 46, 46A, 47, 49, 51, 53, 55, 61, 63, 63A, 66, 117 and 124 (1) (c) & (d) to the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the above named Order.

The provisions of this Order will come into operation on the 28 day of February 2013 and amend the Brighton & Hove (Waiting & Loading/Unloading Restrictions and Parking Places) Consolidation Order 2008 as follows:

#### **SCHEDULE I AMENDMENTS:**

#### Part I.I No Waiting At Any Time

Add new item 338a: Chalkland Rise – Both sides – From the western kerbline of Crescent Drive South westwards for a distance of 7 metres

Add new item 464e: Crescent Drive South – West side – From the northern kerbline of Chalkland Rise northwards for a distance of 7 metres

Add new item 464f: Crescent Drive South – West Side – From the southern kerbline of Chalkland Rise southwards for a distance of 7 metres

Add new item 531b: Davey Drive – West side – From the southern kerbline of The Crossway southwards for a distance of 13 metres

Add new item 854a: Foredown Road – North side – From the western kerbline of Highways westwards for a distance of 35 metres

Amend item 1698a Mill Rise: delete "10 metres" and substitute "14 metres

Amend item 1698b Mill Rise: delete the existing description and substitute "From a point 4 metres east of the boundary between No. 57 Mill Rise and Church Hall of the Ascension, westwards for a distance of 14 metres"

Add new item 2640a: The Crestway – West side – From the northern kerbline of The Crossway northwards for a distance of 8 metres

Add new item 2641a: The Crossway - South side - From the western kerbline of Davey Drive westwards for a distance of 10 metres

Add new item 2641b: The Crossway - North side - From the western kerbline of The Crestway westwards for a distance of 10 metres
