ROAD TRAFFIC REGULATION ACT 1984**

**BRIGHTON & HOVE SEAFRONT (VARIOUS RESTRICTIONS) CONSOLIDATION  
ORDER 2008 AMENDMENT ORDER No.2 2013**

Brighton & Hove City Council in exercise of its powers under Sections 1, 2, 3, 4, 19, 32, 35, 35A, 43, 44, 45, 46, 46A, 47, 49, 51, 53, 55, 61, 63, 63A, 66, 117 and 124 (1) (c) & (d) of the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the above named Order.

The provisions of this Order will come into operation on the *15<sup>th</sup>* day of *March* 2013 and amend the Brighton & Hove Seafront (Various Restrictions) Consolidation Order 2008 as follows:

**ARTICLE AMENDMENTS:**

**PART 1 – GENERAL**

In Article 3 after the paragraph commencing "**Loading Bay**" insert the following:

- "**Low Emission Vehicle**" means a motor vehicle registered on or after 1<sup>st</sup> March 2001 which for the purposes of vehicle excise duty is recognised by the Driver and Vehicle Licensing Agency as qualifying for either tax Band A emitting up to 100g/km of CO<sub>2</sub> or tax Band B emitting between 101 to 120g/km of CO<sub>2</sub>;

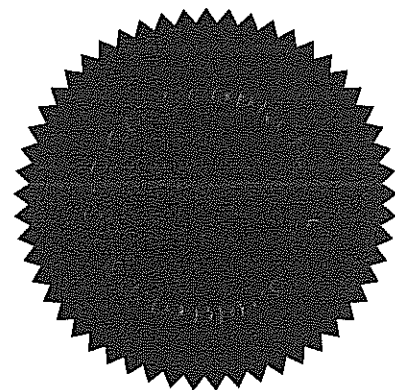
