**Brighton & Hove Various Controlled Parking Zones Consolidation Order 2008  
Amendment Order No.9 2013**

Brighton & Hove City Council ("the Council") in exercise of its powers under Sections 1, 2, 3, 4, 19, 32, 35, 35A, 43, 44, 45, 46, 46A, 47, 49, 51, 53, 55, 61, 63, 63A, 66, 117 and 124 (1) (c) & (d) to the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

1. This Order may be cited as The Brighton & Hove Various Controlled Parking Zones Consolidation Order 2008 Amendment Order No. 9 2013 and shall come into operation on the 5<sup>th</sup> day of September 2013.
2. The Brighton & Hove Various Controlled Parking Zones Consolidation Order 2008 is amended as follows:

**SCHEDULE 1 AMENDMENTS:**

**Controlled Parking Zone J**

**Part 5.4 Shared Permit and Low Tariff Medium Term Pay and Display parking (for a period of up to 4 hours no return with 4 hours) from Monday to Sunday between 9am and 8pm inclusive**

Delete the following:

Item No.	Street Name	Side of Road	Description	CPZ
70	Shaftesbury Road	East	From the northern boundary of property no.94 Shaftesbury Road, northwards to a point 6 metres south of the southern kerbline of Ditchling Road.	J

And replace with:

Item No.	Street Name	Side of Road	Description	CPZ
70	Shaftesbury Road	East	From the northern boundary of property no.94 Shaftesbury Road, northwards to a point 15.6 metres south of the southern kerbline of Ditchling Road.	J



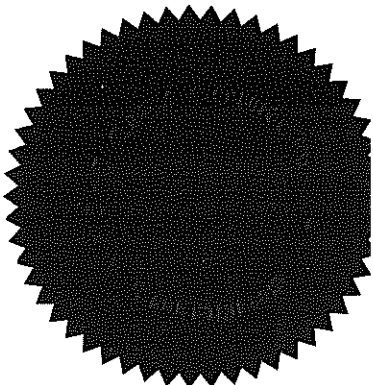
