BRIGHTON & HOVE CITY COUNCIL ROAD TRAFFIC REGULATION ACT 1984

BRIGHTON & HOVE OUTER AREAS (WAITING, LOADING AND PARKING) AND CYCLE LANES CONSOLIDATION ORDER 2013 AMENDMENT ORDER No. I 2014

Brighton & Hove City Council in exercise of its powers under sections 1, 2, 3, 4, 19, 32, 35, 35A, 43, 44, 45, 46, 46A, 47, 49, 51, 53, 55, 61, 63, 63A, 66, 117 and 124 (1) (c) & (d) of the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

- 1. This Order may be cited as The Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2013 Amendment Order No.1 2014 and shall come into operation on the 31 st day of January 2014
- 2. The Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2013 is amended as follows:

SCHEDULE I AMENDMENTS:

Delete existing description for item 105a Barn Rise and substitute with the following:

"From a point 30.5 metres south of the southern kerbline of Bankside southwards for a distance of 9.6 metres

Delete existing item 2429: Rookery Close, Brighton

Delete existing description for item 2433 Rookery Close and substitute with the following:

"From the southern edge of the southern arm's carriageway northwards for 69 metres to include turning area in southern arm."

Add new item 580a: Poynings Drive – West side – From a point 3 metres north of the boundary wall between Nos. 28 & 30 Poynings Drive northwards for a distance of 5.5 metres (outside No.30)

Delete existing item 617: Sandgate Road, Brighton (outside No.49)

Delete existing item 623: Saxon Road, Hove (outside No.5)

Add new item 644a: Sherbourne Road — South side — From a point 5 metres west of the western kerbline of Sherbourne Way westwards for a distance of 5 metres (outside No.79)

Add new item 736a: Thompson Road – East side – From southern boundary wall of Nos.2/4 Thompson Road northwards for a distance of 5.5 metres (outside Nos. 2/4)

Delete existing item 778: Washington Street, Brighton (outside No.82)

Add new item 783a: Whitehawk Crescent – South side – From the western property wall of No.139 eastwards for a distance of 5.5 metres (outside No.139)

Delete existing item 786: Whitehawk Way, Brighton (outside No.10)
