**BRIGHTON & HOVE (OFF-STREET PARKING PLACES) ORDER 2008  
AMENDMENT ORDER No.1 2014**

Brighton & Hove City Council in exercise of its powers under Section 35 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following order:
