ROAD TRAFFIC REGULATION ACT 1984**

**BRIGHTON & HOVE OUTER AREAS (WAITING, LOADING AND PARKING) AND  
CYCLE LANES CONSOLIDATION ORDER 2013 AMENDMENT ORDER No.13 2014**

Brighton & Hove City Council in exercise of its powers under sections 1, 2, 3, 4, 19, 32, 35, 35A, 43, 44, 45, 46, 46A, 47, 49, 51, 53, 55, 61, 63, 63A, 66, 117 and 124 (1) (c) & (d) of the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

1. This Order may be cited as The Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2013 Amendment Order No.13 2014 and shall come into operation on the *1<sup>st</sup>* day of *December* 2014.
2. The Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2013 is amended as follows:

**ARTICLE AMENDMENTS:**

**Part 1**

In article 3:

After existing definition of "Permit Parking Places" insert the following:

**"Personal Disabled Badge Holder's Parking Place"** means a length of road indicated by Traffic Signs authorising it to be used for the leaving of vehicles in accordance with the provisions of this Order;

**Part 3**

Add the following wording after Article 1(2):

and provided also that in the case of Schedule 1 Part 6.3 (Personal Disabled Badge Holders Parking Places) a valid Disabled Resident's Parking Place Permit issued in respect of that particular parking place must also be displayed.

**Part 4.2**

After Article 9 insert the following:

**"Disabled Resident's Parking Place Permit**

10. Any applicant for a Disabled Resident's Parking Place Permit shall produce such evidence as may be required by the Council to satisfy itself that:

(1) the applicant has previously applied for and been granted an existing Disabled Badge Holders Parking Bay in the immediate vicinity of their property which has been in place for not less than six months; and

(2) other vehicles have prevented the applicant from using that Disabled Badge Holders Parking Bay during the six month period immediately preceding the date of the application to such an extent that the Council in its absolute discretion

considers justify the provision of a Personal Disabled Badge Holders Parking Place”

Add new item 638a: Sherbourne Close – East side – From the southern property wall of Nos. 43-44 Sherbourne Close northwards for a distance of 5.5 metres (outside Nos. 43-44)

Add new item 671: St Helen's Road – West side – From a point 18 metres north of the northern kerbline of Elm Grove northwards for a distance of 5.5 metres (outside No.5)

Delete existing item 677: St Leonards Gardens, Hove (outside No.16)

Add new item 691a: Stanmer Park Road – West side – From the boundary between Nos. 71 & 73 Stanmer Park Road southwards for a distance of 5.5 metres (outside No.71)
