BRIGHTON & HOVE VARIOUS CONTROLLED PARKING ZONES CONSOLIDATION ORDER 2008 AMENDMENT ORDER NO.5 2015

Brighton & Hove City Council in exercise of its powers under Sections 1, 2, 3, 4, 19, 32, 35, 35A, 43, 44, 45, 46, 46A, 47, 49, 51, 53, 55, 61, 63, 63A, 66, 117 and 124 (1) (c) & (d) of the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the above named Order.

- 1. This Order may be cited as The Brighton & Hove Various Controlled Parking Zones Consolidation Order 2008 Amendment Order No.5 2015 and shall come into operation on the i^{S^+} day of $A_{PC}i$ 2015.
- 2. The Brighton & Hove Various Controlled Parking Zones Consolidation Order 2008 is amended as follows:

ARTICLE AMENDMENTS:

In Part 3 - Parking Places

Insert the following wording in Articles 2 between Providence Place (from Bartholomew's Church to St Peters Street) and in Controlled Parking Zone Y:

"Part 1.1 for Francis Street"

"From a point 10 metres east of the eastern kerbline of London Road eastwards for a distance of 10 metres."

Add new item 1: Baker Street - South side - From a point 49.6 metres east of the eastern kerbline of London Road eastwards for a distance of 8 metres.
