

## BRIGHTON & HOVE CITY COUNCIL

### Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2013 Amendment No.3 2016

Brighton & Hove City Council ("the Council") in exercise of its powers under Sections 1, 2, 3, 4, 19, 32, 35, 35A, 44, 45, 46, 46A, 47, 49, 51, 53, 55, 61, 63, 63A, 66, 117 and 124 (1) (c) & (d) to the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

1. This Order may be cited as Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2013 Amendment Order No. 3 2016 and shall come into operation on the *22<sup>nd</sup>* day of *February* 2016.
2. Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2013 is amended as follows:

##### **Part 1.1 No Waiting At Any Time**

Delete the following:

Delete the following:-

| Item No | Street Name        | Side of Road | Description   |
|---------|--------------------|--------------|---|
| 23      | Goldstone Crescent | south-west   | From a point 20 metres south of the southern kerbline of Woodland Drive southwards for 90 metres. |

Insert new item as follows:-

| Item No | Street Name        | Side of Road | Description   |
|---------|--------------------|--------------|---|
| 23      | Goldstone Crescent | south-west   | From a point 57 metres south of the southern kerbline of Woodland Drive southwards for 53 metres. |
