# Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2013 Amendment No.7 2016

Brighton & Hove City Council ("the Council") in exercise of its powers under Sections 1, 2, 3, 4, 19, 32, 35, 35A, 44, 45, 46, 46A, 47, 49, 51, 53, 55, 61, 63, 63A, 66, 117 and 124 (1) (c) & (d) of the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

- 1. This Order may be cited as Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2013 Amendment Order No.7 2016 and shall come into operation on the 4th day of April 2016.
- 2. The Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2013 is amended as follows:

## Part 1.1 No Waiting At Any Time

Delete the following items:-

1355	Hollingbury Road	East	From a point opposite the northern flank wall of No. 82 Hollingbury Road, southwards for a distance of 12 metres.
1356	Hollingbury Road	East	From a point opposite the southern boundary of No. 50 Hollingbury Road, southwards for a distance of 12 metres.
1357	Hollingbury Road	West	From a point 1.5 metres north of the northern boundary of No. 95 Hollingbury Road, southwards for a distance of 12 metres.
