ROAD TRAFFIC REGULATION ACT 1984**

**Brighton & Hove Various Controlled Parking Zones Consolidation Order 2015
Amendment Order No.12 2016**

Brighton & Hove City Council ("the Council") in exercise of its powers under Sections 1, 2, 3, 4, 19, 32, 35, 35A, 44, 45, 46, 46A, 47, 49, 51, 53, 55, 61, 63, 63A, 66, 117 and 124 (1) (c) & (d) to the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

1. This Order may be cited as The Brighton & Hove Various Controlled Parking Zones Consolidation Order 2015 Amendment Order No. 12 2016 and shall come into operation on the **7th** day of **November** 2016.
2. The Brighton & Hove Various Controlled Parking Zones Consolidation Order 2015 is amended as follows:

Add the following new items:

Ref No.	Road Name	Side	Description
1	Kingsway	South	From a point 95 metres west of the western kerbline of Hove Street South westwards for a distance of 17 metres.
2	Kingsway	South	From a point 119.5 metres west of the western kerbline of Hove Street South westwards for a distance of 125 metres.
3	Kingsway	South	From a prolongation of the western kerbline of Princes Crescent (western arm) westwards for 84 metres.
4	Kingsway	South	From a point 11m west of the prolongation of the western kerbline of Westbourne Villas eastwards for a distance of 52.5m
5	Kingsway	South	From a point 23 metres east of a prolongation of the eastern kerbline of Sackville Gardens westwards for a distance of 62.5 metres.
6	Kingsway	South	From a point 2 metres west of the prolongation of Sackville Gardens to a point 15.8 metres west of the prolongation of the western kerbline of Braemore Road.
7	Kingsway	South	From a point 15.8 metres west of the prolongation of the western kerbline of Braemore Road to a point 29 metres east of the prolongation of the eastern kerbline of Wish Road.

7	Kingsway	Both	From the junction of Langdale Road to a point 40 metres west of the western kerbline of Saxon Road.

Add the following new items:

Ref No.	Road Name	Side	Description
1	Kingsway	South	From a point 35 metres west of the western kerbline of Wharf Road westwards for a distance of 124.4 metres.
2	Kingsway	South	From a point 4 metres east of the prolongation of the western kerbline of Wish Road westwards for a distance of 15 metres.
