**Brighton & Hove Various Controlled Parking Zones Consolidation Order 2018  
Amendment Order No.6 2021**

Brighton & Hove City Council ("the Council") in exercise of its powers under Sections 1(1), 2(1) to (3), 4 and 124 (1) (c) & (d) to the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

1. This Order may be cited as the Brighton & Hove Various Controlled Parking Zones Consolidation Order 2018 Amendment Order No. 6 2021 and shall come into operation on the 12<sup>th</sup> day of April 2021.
2. The Brighton & Hove Various Controlled Parking Zones Consolidation Order 2018 is amended as follows:

**SCHEDULE 1 AMENDMENTS:**

**Controlled Parking Zone Y**

**Part 2.1 No loading/Unloading At Any Time**

6b	Francis Street	South	From a point 66 metres west of the western kerbline of Ditchling Road westwards to the eastern kerbline of London Road.


