ROAD TRAFFIC REGULATION ACT 1984**

**Brighton & Hove Various Controlled Parking Zones Consolidation Order 2015
Amendment Order No.4 2017**

Brighton & Hove City Council ("the Council") in exercise of its powers under Sections 1, 2, 3, 4, 19, 32, 35, 35A, 44, 45, 46, 46A, 47, 49, 51, 53, 55, 61, 63, 63A, 66, 117 and 124 (1) (c) & (d) to the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

1. This Order may be cited as The Brighton & Hove Various Controlled Parking Zones Consolidation Order 2015 Amendment Order No. 4 2017 and shall come into operation on the *18th* day of *April* 2017.
2. The Brighton & Hove Various Controlled Parking Zones Consolidation Order 2015 is amended as follows:

ARTICLE AMENDMENTS

Part 1

In paragraph 3 – delete the following definition:-

"Low Emission Vehicle" means a Motor Vehicle registered on or after 1st March 2001 which for the purposes of vehicle excise duty is recognised by the Driver and Vehicle Licensing Agency as qualifying for either tax Band A emitting up to 100g/km of CO₂ or tax Band B emitting between 101 to 120g/km of CO₂; "

And replace with:-

"Low Emission Vehicle" means a Motor Vehicle registered on or after 1st March 2001 which for the purposes of vehicle excise duty is recognised by the Driver and Vehicle Licensing Agency as qualifying for either tax Band A emitting up to 100g/km of CO₂ or tax Band B emitting between 101 to 120g/km of CO₂. Diesel vehicles are not eligible as a Low Emission vehicle;"

On items 2 to 4 Resident Permit (Low Emission Vehicle) insert '50% reduction' before 'Low'.


On items 9 & 1- Business Permit (Low Emission Vehicle) insert '50% reduction' before 'Low'

On items 16 & 17 Trader Permit (Low Emission Vehicle) insert '50% reduction' before 'Low'

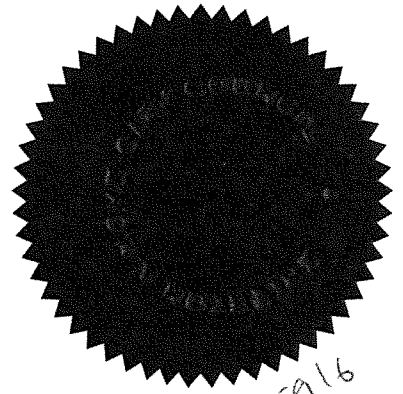
