**BRIGHTON & HOVE (WAITING & LOADING/UNLOADING
RESTRICTIONS AND PARKING PLACES) CONSOLIDATION ORDER 2008
AMENDMENT ORDER No.4 2010
(BOUNDARY ROAD & STATION ROAD)**

Brighton & Hove City Council in exercise of its powers under Sections 1, 2, 3, 4, 19, 32, 35, 35A, 43, 44, 45, 46, 46A, 47, 49, 51, 53, 55, 61, 63, 63A, 66, 117 and 124 (1) (c) & (d) to the Road Traffic Regulation Act 1984 as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers hereby make the above named Order.

The provisions of this Order will come into operation on the *21st* day of *June* 2010 and amend the Brighton & Hove (Waiting & Loading/Unloading Restrictions and Parking Places) Consolidation Order 2008 as follows:-

SCHEDULE I AMENDMENTS:

PART I.1 No Waiting at Any Time

Amend description of existing item Ref. no.229 Boundary Road – Hove: delete “From the southern kerbline of Portland Road south for 14 metres” and substitute the following:

“From the southern kerbline of Portland Road southwards for 20.8 metres”

Delete existing item Ref. no. 2545: “Station Road – Portslade – West - From a point 11.5 metres south of the prolongation of the southern kerbline of Portland Road northwards for a distance of 51.5 metres – 1975” and substitute the following:

Add new item as follows:

Delete existing item Ref. no.2546: “Station Road – Portslade – West - From a point 15 metres north of the northern kerbline of Vale Road southward to a point 15 metres south of the southern kerbline of Vale Road -1983” and substitute the following two items:

2546	Station Road - Portslade	West	From the northern kerbline of Vale Road northwards for a distance of 10 metres	2010
2546a	Station Road - Portslade	West	From the southern kerbline of Vale Road southwards for 17 metres	2010

PART 1.4 No Waiting Monday to Saturday 8.00am – 6.00pm

Delete existing item Ref. no. 10 "Boundary Road – Hove – East - From a point 13.7 metres south of the southern kerbline of Portland Road south to a point 47 metres north of the northern of New Church Road"

Delete existing item Ref. no. 58 "Station Road – West - From a point opposite the boundary between the Railway Tavern and No. 3 Station Road southward to a point 15 metres north of the northern kerbline of Vale Road"

Amend description of existing item Ref. no. 13 "Boundary Road – Hove: delete "From a point 14 metres south of its junction with Portland Road southwards for a distance of 24 metres" and substitute the following:

"From a point 20.8 metres south of its junction with Portland Road southwards for a distance of 18 metres"

Add new items as follows:


