**THE HERTFORDSHIRE (BREWERY ROAD, HODDESDON)
(PROHIBITION OF DRIVING EXCEPT BUSES AND PEDAL CYCLES)
ORDER 2004**

The Hertfordshire County Council in exercise of their powers under Sections 1(1) 2(1) to (3) and 3 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 hereby make the following Order:-

1. This Order may be cited as "The Hertfordshire (Brewery Road, Hoddesdon) (Prohibition of Driving except Buses and Pedal Cycles) Order 2004" and shall come into operation on Monday 3 October 2005.
2. Save as provided in Article 3 to this order no person shall cause or permit any vehicle other than a bus or pedal cycle to enter or proceed along that length of westbound carriageway in Brewery Road Hoddesdon from its junction with Sainsburys Car Park Service Road westwards to its junction with High Street.

In this Order

"pedal cycle" – has the same meaning as that defined by Section 192(1) Road Traffic Act 1988

"bus" – has the same meaning as "public service vehicle" defined by Section 142(1) Road Traffic Regulation Act 1984.

- 3(1) Nothing in Article 2 of this order shall apply so as to prevent any person from causing or permitting any motor vehicle to enter or proceed along that length of Brewery Road, Hoddesdon specified in Article 2 to this order if the vehicle is being used in connection with;
 - (a) Fire and Rescue, Ambulance or Police being used for emergency purposes.
 - (b) Anything done with the permission of or at the direction of –
 - (i) a police officer in uniform;
 - (ii) a traffic warden.
 - (c) Access by statutory authorities in connection with any maintenance, repair or replacement of any gas, water, electricity or telecommunications equipment or apparatus located within that length of Brewery Road.
 - (d) Crossing the width of that length of Brewery Road specified in Article 2 for the purpose of access to or egress from any service road or private driveway located adjacent to the southern kerbline.
 - (e) Anything done in order to prevent an accident or avoid injury or damage to persons or property or when required to do so by law.
 - (f) Access by any vehicle in order that it may be used for one or more of the purposes specified in sub Article 2 of this Article and which cannot reasonably be used for such a purpose without entering or proceeding along that length of Brewery Road specified in Article 2.

(2) The "purposes" referred to in sub-Article (1)(d) of this Article are –

- (a) any operation involving building, demolition or excavation;
- (b) the removal of any obstruction to traffic;
- (c) the maintenance, improvement or reconstruction of a road;
- (d) constructing, improving, maintaining, or cleaning of any street furniture; or
- (e) the laying, erection, alteration, repair or cleaning of any sewer or of any main pipe or apparatus for the supply of gas, water or electricity, or of any telecommunications apparatus kept or installed for the purposes of a telecommunications code system or of any other telecommunications apparatus lawfully kept installed in any position.

4. The Hertfordshire County Council in making this order are satisfied that this Order is required to avoid the likelihood of danger to persons using that length of road specified in Article 2 of this Order.


5. The provisions of the following Order are hereby revoked;

6. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
