THE HERTFORDSHIRE (HIGH STREET, WALTHAM CROSS) (PROHIBITION OF STOPPING AND WAITING EXCEPT TAXIS) ORDER 2005

The Hertfordshire County Council in exercise of their powers under Sections 1, 2, 3 and 4 of the Road Traffic Regulation Act 1984 (which said Act of 1984 is hereinafter referred to as "the Act of 1984"), and Part IV of the Act of 1984 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984, hereby make the following Order:-

- This Order may be cited as "The Hertfordshire (High Street, Waltham Cross)
 (Prohibition of Stopping and Waiting except Taxis) Order 2005" and shall come into
 operation on Friday 25 August 2006.
- 2. Save as provided in Article 3 of this Order no person shall cause or permit any vehicle other than a taxi to stop or wait at any time in that length of High Street, Waltham Cross, specified in the Schedule to this Order.

In this Article 'taxi' shall have the meaning as -

'a vehicle licensed by the Borough of Broxbourne Council under Section 37 of the Town Police Clauses Act 1847 or any other similar enactment'.

- 3(1) Nothing in Article 2 of this Order applies to the length of road restricted by that Article (which said length of road is referred to in this Article as "the restricted area") in relation to
 - (a) a vehicle being used for Fire and Rescue, Ambulance or Police purposes during the course of an emergency.
 - (b) anything done with the permission of or at the direction of a Police Officer in uniform.
- 4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 5. The provisions of the following Order are hereby revoked only in so far as they are affected by the restrictions imposed by this Order

6. The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

SCHEDULE

length of High Street, Waltham Cross - no stopping or waiting except taxis

High Street (west side)

from a point 11.5 metres south of its junction with the south kerbline of Regent Gate Estate Road southwards for 25 metres.

High Street Service Road (fronting no's 89 to 97 High Street) (west side)

(a) from its junction with the north kerbline of Regent Gate Estate Road northwards for 10 metres.

(b) from a point 14 metres north of its junction with the north kerbline of Regent Gate Estate Road northwards and north eastwards for 12.5 metres.
