NOTICE OF VARIATION

NOTICE IS HEREBY GIVEN that the Burnley Borough Council in exercise of its powers under Section 35C of the Road Traffic Regulation Act 1984 intends, on the 1st February 2013, to vary the scale of charges specified in Column 7 of the Schedule to the Borough of Burnley (Off Street Parking Places) Order 2010, the effect of which is specified in Schedule 1 to this Notice and to vary the scale of charges specified in Column 7 of Schedule 2 to The Borough of Burnley (Thomas Street) (Off Street Parking Places) Order 2011, the effect of which is specified in Schedule 2 to this Notice.

The Burnley Borough Council also intends, on the 1st February 2013, to vary some of the hours of charging as specified in Column 5 of the Schedule to the Borough of Burnley (Off Street Parking Places) Order 2010, the effect of which is specified in Schedule 3 to this Notice.

The classes of Vehicles, the days of operation and the maximum period for waiting in relation to the said Parking Places remain as specified in the Schedule to the Borough of Burnley (Off Street Parking Places) Order 2010 and Schedule 2 to The Borough of Burnley (Thomas Street) (Off Street Parking Places) Order 2011.
