THE METROPOLITAN BOROUGH OF BURY (ROCHDALE OLD ROAD AREA, BURY), (RESIDENTS ONLY PARKING) & (PROHIBITION OF WAITING) ORDER 2016

The Council of the Metropolitan Borough of Bury in exercise of the powers under Sections 1(1), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984 (hereinafter called "the said Act of 1984") and of all other enabling powers and after consultation with the Chief Officer of Police for the County of Greater Manchester in accordance with Part III of Schedule 9 of the said Act of 1984, hereby make the following Order:-

1. (1) In this Order:

"civil enforcement officer" has the same meaning as in the Traffic Management Act 2004;

- (2) (i) any reference to Post Office vehicle shall be deemed to be a reference to a vehicle of a universal service provider
 - (ii) any reference to a vehicle bearing Royal mail livery shall be deemed to include a reference to a vehicle bearing a livery which is used by a universal service provider
 - (iii) any reference to the carrying out of a statutory duty of the Post Office shall be deemed to be a reference to the provision of a universal postal service"
- (3) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 2. Save as provided in Article 3 of this Order no person shall except upon the direction or with the permission of a police constable in uniform or of a civil enforcement officer, cause or permit any vehicle to wait between the hours of 8.00 am and 6.00 pm Mondays to Fridays inclusive, or cause or permit any goods to be loaded or unloaded from any vehicle during the same hours/days in the side(s) and length(s) of road(s) specified in the Schedule.
- 3. Nothing In Article 2 of this Order shall render it unlawful to cause or permit any vehicle to wait in the side(s) and length(s) of road(s) referred to in that Article for so long as may be necessary to enable:-
 - (1) a person to board or alight from the vehicle;
 - (2) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any funeral, building, industrial or demolition operations, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of any of the length(s) of road referred to or the laying, erection,
