TRAFFIC MANAGEMENT ORDER

THE BOROUGH COUNCIL OF CALDERDALE

(HEBDEN BRIDGE CENTRAL AREA)

(CONTROLLED PARKING ZONE) (CONSOLIDATION) ORDER 2008

The Borough Council of Calderdale in exercise of its powers under Sections 1, 2, 32, 35 45, 46, 49, 51 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as the Act of 1984") and of all other enabling powers, hereby makes the following Order:-

Commencement and Citation

This Order may be cited as The Borough Council of Calderdale (Hebden Bridge Central Area) (Controlled Parking Zone) (Consolidation) Order 2008 and will come into force on the 31st March 2008.

PART 1

DEFINITIONS

1. (1) In this Order, except where the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them:-

"the Act of 1984" means the Road Traffic Regulation Act 1984 (as amended);

"apparatus" has the same meaning as in Section 405 of the Communications Act 2003;

"carriageway" has the same meaning as in Section 329(1) of the Highways Act 1980;

"the Council" means The Borough Council of Calderdale;

"chargeable hours" means between the hours of 8.00 am and 6.00 pm on all days unless such day falls on a Bank Holiday;

"coach" means a vehicles constructed or adapted solely for the carriage of passengers and their effects and constructed or adapted to carry more than eight passengers excluding the driver;

"controlled parking zone" means the streets described in the First Schedule to this Order and shown on Drawing Nos: 72/404/101-105;

"disabled persons badge" and "disabled person" have the same meaning as in the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000;

"disabled persons vehicle" means a vehicle displaying a disabled persons' badge;

"driver" in relation to a vehicle waiting in a parking place, means the person driving the vehicle at the time it was left in the parking place;

"goods" means goods of any kind whether animate or inanimate and includes postal packets of any description; and "delivering" and "collecting" in relation to any goods includes checking the goods for the purpose of their delivery or collection;

"goods vehicle" has the same meaning as in Regulation 4 of the Traffic Signs Regulations and General Directions 2002;

"goods carrying vehicle" means a motor vehicle or trailer which is constructed or adapted for use for the carriage or haulage of goods or burden and is not drawing a trailer and has a maximum gross weight of 7.5 tonnes;

"invalid carriage" has the same meaning as in Section 136(5) of the Act of 1984;

"licensed taxi" has the same meaning as in Section 13 of the Transport Act 1985;

"loading or unloading" means the waiting of a vehicle for the commercial purpose of the delivery of goods to or the receipt of goods from adjacent premises, the volume, weight or bulk of the goods being such that it would not be reasonable to expect the goods to be otherwise delivered or received;

"motor cycle" means a mechanically propelled vehicle (not being an invalid carriage) with fewer than 4 wheels, of which the weight unladen does not exceed 410 kilograms;

"owner", in relation to a vehicle, means the person by whom such vehicle is kept and used;

"civil enforcement officer" means a person authorised by or on behalf of the Council to supervise any parking place and to carry out such other functions as may be conferred by or under any enactment;

"parking charge" means the sum(s) payable for the purchase of a Parking Ticket as set out in Article 30 hereof;

"parking period" means the period beginning from the time the vehicle was first left in the parking place and ending on the expiration of the period of time for which payment was made at the time of first leaving the vehicle;

"parking place" means an area on a highway designated or authorised and described as a parking place by any of the various Articles or Schedules of this Order;

"parking space" means a space in a parking place which is provided for the leaving of a vehicle;

"pay and display" means the description given to the areas of highway designated as parking places by this Order and signed as "pay and display" adjacent to those parking places;

" permit" means a parking permit or special permit issued by the Council;

"permitted hours" means all hours;

"postal packet" shall have the same meaning as in Section 125 (1) of the Postal Services Act 2000;

"public service vehicle" means a motor vehicle (other than a tram car) which

- (a) being a vehicle adapted to carry more than eight passengers, is being used for carrying passengers for hire or reward; or
- (b) being a vehicle not so adapted, is being used for carrying passengers for hire or reward at separate fares in the course of a business of carrying passengers, and for the purpose of this Order a public service vehicle shall be deemed to wait for more than two minutes in the same place if any one part of the road is below any part of the vehicle or its load (if any) throughout a period exceeding two minutes whether or not the vehicle is moved during that period;

"relevant position" insofar as it relates to the display of a disabled person's badge has the same meaning as in Regulation 12 of the Disabled Persons' (Badges for Motor Vehicles) (England) Regulations 2000;

"relevant position" insofar as it relates to the display of a disabled person's parking disc has the same

meaning as in Regulation 4 of the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000;

"relevant position" insofar as it relates to a ticket means:-

- (i) in the case of a vehicle fitted with a front windscreen a ticket is displayed so that it is directed outwards from immediately behind the window adjacent to the windscreen and nearest to the edge of the carriageway so that it is clearly visible to a person outside the vehicle, in order that the time at which the vehicle was identified as having been left in the parking place for the purposes of this Order can be ascertained with reference to the indications of the month, date of the month, day of the week, hour of the day and minute of the hour to the nearest five minutes within the hour of the day;
- (ii) in the case of a vehicle not fitted with a front windscreen a ticket is displayed so that the obverse face is directed outwards on the front or on the side of the vehicle nearest to the edge of the carriageway so that it is clearly visible to a person by the side of the vehicle in order that the time at which the vehicle was identified as having been left in the parking place for the purpose of this Order can be ascertained with reference to the indications of the month, date of the month, day of the week, hour of the day and minute of the hour to the nearest five minutes within the hour of the day;

"the 2000 Regulations" means the Local Authorities Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000;

"road" means any length of highway or of any other road to which the public has access, and includes bridges over which a road passes;

"the 2002 Regulations" means the Traffic Signs Regulations and General Directions 2002;

"special permit" means a permit issued to any person under the provisions of Article 37 of this Order;

"ticket" means a ticket issued by the ticket parking meter relating to a parking place;

"ticket parking meter" means an apparatus of a type and design in accordance with and approved by the Secretary of State for Transport for the purposes of this Order being an apparatus designed to indicate the time and to issue tickets indicating the payment of the parking charge referred to in this Order and the period in respect of which the charge has been paid in respect of a vehicle in a parking place within a pay

and display area or a pay and display zone;

"traffic sign" means a sign of any size, colour and type prescribed or authorised under, or having effect as though prescribed or authorised under section 64 of the Act of 1984;

- (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- (3) Any reference in this Order to a ticket parking meter relating to a parking place shall be construed as a reference to any ticket parking meter which is situated within the length of the highway in which that parking place is situated.

PART 2

GENERAL PROHIBITION OF WAITING AND LOADING

- 2. (a) Subject to the provisions of paragraphs (c) to (i) no person shall cause or permit any vehicle to wait at any time on any length of road specified in the FirstSchedule to this Order.
 - (b) Subject to the provision of paragraph (c) no person shall load or unload any vehicle during the periods on any of the lengths of road that are specified in the Third and Fourth Schedules to this Order.
 - (c) The prohibition specified in paragraph (a) and (b) subject to the provisions of this Order does not apply in respect of such vehicles as are public service vehicles, a taxi waiting in a taxi rank appointed by the Council, goods carrying vehicles parked in a parking space specified in the Fifth Schedule, or disabled persons vehicles parked in a parking place specified in the Eighth Schedule to this Order.
 - (d) The prohibition specified in paragraph (a) subject to the provision of this Order does not apply in respect of any vehicle permitted to park in a parking space specified in the Sixth, Seventh, Ninth, Tenth and Seventeenth Schedules to this Order.
 - (e) Nothing in paragraph (a) shall apply in any respect on any length of road specified in the Second Schedule to this Order.

- (f) Nothing in paragraph (a) shall apply in respect of a person causing a vehicle to wait if that person is:-
 - (i) waiting to enable a person to board or alight from the vehicle;
 - (ii) required by law to cause the vehicle to stop or not to proceed;
 - (iii) obliged to stop the vehicle so as to avoid an accident;
 - (iv) prevented from proceeding in the vehicle by circumstances beyond their control.
 - (v) getting or giving help in consequence of an accident or an emergency, or otherwise taking action for public safety;
 - (vi) opening or closing a gate or other barrier at the entrance to premises to which the vehicle is being driven or from which it has emerged if it is not reasonably practicable to cause the vehicle to wait elsewhere for the purpose;
 - (vii) using the vehicle for fire brigade, ambulance or police operational purposes;
 - (viii) using the vehicle in connection with the removal of any obstruction to traffic;
 - (ix) using the vehicle in connection with the maintenance, improvement or reconstruction of any length of road specified in the First Schedule to this Order or any other such roads as are adjacent to any length of road specified in the said Schedule;
 - (x) using a licensed taxi to stop for so long only as may be reasonably required to enable a passenger to get on or off the vehicle or load thereon or unload therefrom their personal luggage;
 - (xi) Nothing in paragraph (a) shall render it unlawful to cause or permit any vehicle to wait for a period not exceeding three hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle in the same road or part of road on the same day) in the length of road specified in the First Schedule to this Order if the vehicle displays in the relevant position a disabled persons badge and a parking disc issued by any local authority in accordance with the provisions of The Disabled Persons (Badges for Motor Vehicle) (England) Regulation 2000, or a badge having effect under these Regulations as if it were a Disabled Person's Badge and the driver, or other person in charge of the vehicle, marks on the parking disc the time at which the period of waiting began;
 - (xii) waiting for a period not exceeding two minutes or such longer period as a parking attendant in uniform or a person identifiable as being responsible for Parking Services may approve to enable a person to board or alight from the vehicle or load thereon or unload therefrom their personal luggage;
 - (xiii) using the vehicle, not being a passenger vehicle, in the service of a local authority in pursuance of statutory powers or duties provided that in all the circumstances it is reasonably necessary in the exercise of such powers or in the performance of such duties

- for the vehicle to wait in the place in which it is waiting;
- (xiv) using the vehicle in actual use in connection with the removal of furniture to or from one office or dwelling house adjacent to the place in which the vehicle is waiting from or to a depository, another office or dwelling house provided that notice is given 24 hours in advance to the Council's Parking Services and their consent obtained; or
- (xv) in any other case, loading or unloading the vehicle at premises adjacent to the place in which the vehicle is waiting and the vehicle does not wait for a period exceeding thirty minutes or for such longer period as a civil enforcement officer in uniform may approve.
- (g) The restrictions in paragraphs (a) and (b) do not apply in respect of a vehicle which is in the service of a Universal Service Provider and which is waiting at the edge of a carriageway for as long as may be necessary for the purpose of collecting or delivering postal packets.
- (h) No parking charge specified in the provisions hereunder of this Order shall be payable in respect of any vehicle waiting in a parking place in accordance with paragraph (c).
- (i) The restrictions in paragraph (a) and (b) do not apply to anything done with the permission or at the direction of a civil enforcement officer in uniform.
- 3. The Council are satisfied that, for facilitating the passage of vehicular traffic on the specified roads, it is requisite that Section 3 (1) of the Act of 1984 should not apply in relation to this Order.

PART 3 PARKING PLACES

<u>PART A</u> AUTHORISATION AND USE OF PARKING PLACES

Authorisation and Use

- 4. Each area on a highway comprising the lengths of carriageway described in the Fifth, Sixth, Seventh, Eighth, Ninth, Tenth and Seventeenth Schedules to this Order and bounded on one side of that length by the edge of the carriageway and having a width throughout of 2 metres, except for those within the Fifth, Eighth and Tenth Schedules which shall have a width of 2.7 metres, is designated as a parking place.
- 5 (1) The parking places described in the Fifth Schedule to this Order are authorised for the purpose of

loading only and the days and hours of operation of the parking places shall be as specified in the Schedule.

- (2) The parking places described in the Eighth Schedule to this Order are authorised for the use of disabled persons vehicles and the days and hours of operation of the parking places shall be on all days and at all hours.
- (3) The parking places described in the Sixth Schedule to this order are authorised for the use of vehicles for free of charge general parking and the days and hours of operation of the parking places shall be as specified in the Schedule.
- (4) The parking places described in the Seventh Schedule to this Order are authorised for the use of vehicles displaying a parking permit issued in accordance with the Council's Parking Permit Scheme for the said parking place and where specified in the Schedule for general parking by all persons and the days and hours of operation are as specified in the Schedule.
- (5) The parking places described in the Ninth Schedule to this Order are designated for Pay and Display Parking and the days and hours of operation are as specified in the schedules.
- (6) The parking place described in the Tenth Schedule to this Order is authorised for the use of vehicles constructed or adapted solely for the carriage of passengers and their effects and constructed or adapted to carry more than eight passengers excluding the driver, and the days and hours of operation are as specified in the Schedule.
- (7) The parking place described in the Seventeenth Schedule to this Order is authorised for the use of police vehicles and the days and hours of operation of the parking place are as specified in the Schedule.
- 6. All classes of vehicles are permitted to use the parking places described in the Fifth Schedule to this Order and all such vehicles other than vehicles in excess of 3.5 tonnes maximum gross weight are permitted to use the parking places described in all the other Schedules to this Order excluding the parking place described in Schedule 10 which is restricted to vehicles complying with Article 5(6) to this Order.
- 7. (1) All vehicles using a parking place shall wait thereon in a position that is parallel to the edge of the carriageway and wholly within the limits of the parking place as marked on the carriageway with relevant marking as indicated in Schedule 6 of The Traffic Signs Regulations and General

Directions 2002.

- (2) No part of any vehicle using a parking place shall obstruct any vehicular means of ingress to or egress from any premises adjacent to the side of the road on which the vehicle is waiting.
- (3) For the purposes of the last foregoing sub-paragraph, the expression "premises" shall not include any premises to or from which any furniture is being removed by virtue of the provisions of Article 26(1) (g) or to or from which goods are being delivered or collected by virtue of the provisions of Article 26(1) (h).
- 8. (1) The driver of a vehicle shall not permit it to wait in the parking places specified in the Fifth, Sixth, Seventh, Eighth, Tenth and Seventeenth Schedules to this Order for longer than the maximum period permitted for waiting specified in the relevant Column of the Schedules which is headed "Maximum Period For Which A Vehicle May Wait".
 - (2) When a vehicle has left a parking place specified in the Fifth, Sixth, Seventh,-Eighth, Tenth and Seventeenth Schedules to this Order after waiting thereon the driver shall not cause or permit it to wait again upon the parking place within the minimum return period specified in that Column of the said Schedule's which is headed "Maximum Period For Which A Vehicle May Wait".
 - (3) The restrictions outlined in paragraphs (1) and (2) of this Article shall not apply to a vehicle displaying a disabled persons badge when parked in the parking places specified in the Sixth Schedule or the parking place specified in item 7 of Schedule 7.
- 9. Nothing in Article 3 of this Order shall restrict the power of the Council's Parking Services to suspend any parking place or any part thereof in accordance with the provisions of Article 23 of this Order.

Pay and Display Parking Places

10. SAVE as provided for in Part D of this Order no person shall, except upon the direction or with the permission of a civil enforcement officer in uniform, cause or permit any vehicle to wait during the chargeable hours in any of the parking places specified in the Ninth Schedule to this Order unless it is a vehicle which displays in the relevant position a ticket issued by a ticket parking meter as provided for in Part C of this Order.

PROVIDED that:

- (i) the provisions of this Article shall not apply to vehicles that wait in any of the parking spaces specified in the Ninth Schedule to this Order that display in the relevant position a permit as provided for in Part D of this Order, or a disabled persons badge or a motorcycle.
- 11. No charge shall be payable in respect of any vehicle waiting in a designated parking place in accordance with the provisions of Part D of this Order.

Disabled Parking Places

12. Save as provided in Part E of this Order no person shall, except upon the direction or with the permission of a civil enforcement officer in uniform, cause or permit any vehicle to wait in any of the parking places specified in the Eighth Schedule to this Order unless it is a disabled persons vehicle which displays in the relevant position a disabled persons badge and observes the days, hours and maximum periods of use specified therein.

Permit Parking Places

13. Save as provided in Part E of this Order, no person shall, except upon the direction or with the permission of a civil enforcement officer in uniform, cause or permit any vehicle to wait in any of the parking places specified in the Seventh Schedule to this Order, unless it is a vehicle displaying a permit issued by the Council in accordance with the provisions of Part D of this Order or specific provision is made for the waiting of any vehicle as specified in Column 2 of the said Schedule.

Administration of Parking Schemes

- 14. (1) The administration of the Pay and Display Parking Scheme shall be in accordance with the provisions of Part C of this Order.
 - (2) The Council may upon application to the Council issue a special parking permit to any person for the leaving of a vehicle of the class specified in a designated parking place referred to in the Seventh and Ninth Schedules to this Order.

Such application shall be made on a form issued by and obtainable from the Council and shall include the particulars and information required by such a form.

PART B

CONDUCT OF PARKING PLACES

- 15. (1) Where in this Order a parking place is specified as being available for vehicles of a particular class, the driver of a vehicle shall not permit the vehicle to wait in that parking place unless the vehicle is of the particular class;
 - (2) Where in this Order the position in which vehicles or a particular class of vehicle may wait is specified the driver of a vehicle shall not permit the vehicle to wait in the parking place other than in a position specified for that vehicle or class of vehicle.
- 16. Save as provided in Articles 2 (f) and 26 of this Order the driver of a vehicle other than that of a specified class shall not use the parking place unless authorised to do so by a civil enforcement officer in uniform, always provided that no vehicle shall use the parking place -
 - (a) so as unreasonably to prevent access to any premises adjoining the road, or the use of the road by other persons, or so as to be a nuisance;
 - (b) when for preventing obstruction of the streets Calderdale Borough Council by Order made on the occasion of any public procession rejoicing or illumination or when the streets are thronged or liable to be obstructed have closed that parking place and exhibited notice of such closure on or near that parking place;

provided always that a police constable in uniform or PCSO may at any time require the driver of the vehicle to move it if reasonably necessary for the purpose of preventing danger or obstruction.

- 17. The driver of a vehicle using a parking place shall stop the engine as soon as the vehicle is in position in the parking place and shall not start the engine except when about to change the position of the vehicle in or to depart from the parking place.
- 18. No person shall:-
 - (a) sell, offer or exhibit for sale or hire any vehicle while it is in a parking place or
 - (b) use a vehicle, while it is in a parking place, in connection with the sale of any article to persons in or near the parking place or in connection with the selling or offering for hire of their skills or services in any capacity

Provided that nothing in this Article shall prevent the sale of goods from a vehicle:

- (a) if the vehicle is a passenger vehicle, a goods vehicle, a motor cycle or an invalid carriage and the goods are immediately delivered at or taken into the premises adjacent to the vehicle from which the sale is affected; or
- (b) if the vehicle is one to which the provision of Article 26 (1) (h) or (i) of this Order apply.
- 19. No person shall carry out upon any vehicle while it is in a parking place any work of construction, cleaning, maintenance or repair except such as may be necessary to enable the vehicle to be moved from the parking place.
- 20. No person shall post, affix, place or otherwise leave in a parking place or on or to any vehicle using a parking place any leaflet, poster, paper, or other similar material which advertises or publicises any goods, articles, services, or facilities provided or to be provided by that person or by anyone else.

Removal of Parking Ticket Or Parking Permit

21. Where a parking ticket or parking permit has been displayed on a vehicle in accordance with the provisions of this Order no person not being the driver of the vehicle shall remove the said parking ticket or parking permit from the vehicle unless authorised to do so by the driver of the vehicle.

Movement of Vehicles

22. In case of an emergency a civil enforcement officer in uniform or a police constable in uniform may move or cause to be moved any vehicle left in a parking place to any place he thinks fit

Power to Suspend Parking Places

- 23. (1) The Council's Parking Services may suspend the use of a parking place or any part thereof whenever they consider such suspension reasonably necessary:-
 - (a) by reason of works being or proposed to be executed on or near the road or by reason of the likelihood of danger to the public or of serious damage to the highway;

- (b) for the purposes of facilitating the movement of traffic or promoting its safety;
- (c) for the purpose of any building operation, demolition or excavation in or adjacent to the parking place or the maintenance, improvement or reconstruction of the parking place or the laying, erection, alteration, removal or repair in or adjacent to the parking place of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line or traffic sign;
- (d) for the convenience of occupiers of premises adjacent to the parking place on any occasion of the removal of furniture from one office or dwelling house to another or the removal of furniture from such premises to a depository or to such premises from a depository provided that notice is given 24 hours in advance to the Council's Parking Services and their consent obtained;
- (e) on any occasion on which it is likely by reason of some special attraction that any street will be thronged or obstructed; or
- (f) for the convenience of occupiers of premises adjacent to the parking place at times of weddings or funerals, or on other special occasions.
- (2) Any person suspending the use of a parking place or any part thereof in accordance with the provisions of paragraph (1) of this Article shall thereupon place or cause to be placed in or adjacent to any part of that parking place a traffic sign indicating that waiting by vehicles is prohibited.
- (3) Any person for whom the use of a parking place or any part thereof specified in the Ninth Schedule of this Order has been suspended in accordance with the provisions of paragraph (1) of this Article except in paragraph (1)(b) of this Article shall be liable to a daily charge of twenty four times the hourly rate of the parking charge for each parking bay suspended in respect of each day or part day thereof during which the use of the parking place or part thereof is suspended.
- (4) No person shall cause or permit a vehicle to be left in any parking place or part of a parking place during such period as there is in or adjacent to that parking place or part of a parking place a traffic sign placed in pursuance of Paragraph (2) of this Article PROVIDED THAT nothing in this paragraph shall render it unlawful to cause or permit any vehicle being used for any purpose specified in Article 26(1)(c) or (d) of this Order to be left in a parking place or part of a parking

place during any such period, or to any vehicle so left if that vehicle was left with the permission (a) of the person suspending the use of the parking place or part thereof in pursuance of paragraph (1) of this Article or (b) a civil enforcement officer in uniform.

Designation of parking places

24. Each area on a highway comprising the length of carriageway of a street specified in Column 1 of the Fifth, Sixth, Seventh, Eighth, Ninth, Tenth and Seventeenth Schedules to this Order is designated as a parking place.

Vehicles for which parking places are designated

25. Each parking place referred to in the Schedules to this Order may be used, subject to the provisions of this Order, for the leaving during the permitted hours of such vehicles as are provided for in Article 6 to this Order and in so far as the parking places referred to in the Ninth Schedule display a valid ticket during the chargeable hours in accordance with the provisions of Article 30.

Restriction on waiting by a vehicle in a parking place

- 26. (1) Notwithstanding any other provisions of this Order, any vehicle may wait during the permitted hours anywhere in any part of a parking place if the use of that part has not been suspended and if:
 - (a) the vehicle is waiting for a period not exceeding two minutes, or such longer period as a civil enforcement officer in uniform may approve, to enable a person to board or alight from the vehicle or load thereon or unload therefrom his personal luggage:-
 - Provided that, if the said person is a person suffering from any disability or injury which seriously impairs his ability to walk or who is blind, the vehicle may wait for as long as may be necessary to enable that person to board or alight from the vehicle or load thereon or unload therefrom his personal luggage;
 - (b) the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid an accident;
 - (c) the vehicle is being used for fire brigade, ambulance or police purposes or, not being a

passenger vehicle, is being used in the service of a local authority in pursuance of statutory powers or duties, provided that in all the circumstances it is reasonably necessary in the exercise of such powers or in the performance of such duties for the vehicle to wait in the place in which it is waiting;

- (d) the vehicles is waiting only for so long as may be necessary to enable it to be used in connection with the removal of any obstruction to traffic;
- (e) the vehicle is in the service of a Universal Service Provider and it is waiting;
 - (i) while postal packets addressed to premises adjacent to the parking place in which the vehicle is waiting are being unloaded from the vehicle and delivered; or
 - (ii) while postal packets are being collected and loaded on the vehicle from premises or posting boxes adjacent to the parking place in which the vehicle is waiting;
- (f) the vehicle not being a passenger vehicle is waiting only for so long as may be reasonably necessary to enable it to be used for any purposes specified in Article 23 (1) (b) of this Order.
- (g) the vehicle is in actual use in connection with the removal of furniture to or from one office or dwellinghouse adjacent to the parking place from or to a depository, another office or dwellinghouse provided that notice is given 24 hours in advance to the Council's Parking Services and their consent is obtained;
- (h) in any other case, the vehicle is waiting for the purpose of delivering or collecting goods or loading or unloading the vehicle at premises adjacent to the parking place in which the vehicle is waiting and the vehicle does not wait for a period exceeding thirty minutes or for such longer period as a civil enforcement officer in uniform may approve; or
- (i) the vehicle is waiting otherwise than in a parking space if goods are being sold or offered or exposed for sale from the vehicle by a person who is licensed by the Council to sell goods from a stationary vehicle on a pitch situated in the parking place.
- (2) No parking charge specified in any other provisions of this Order shall be payable in respect of any vehicle waiting in a parking place in accordance with the provisions of this Article.

- (3) Except as provided by this Order, the driver or person in charge of a vehicle shall not cause or permit the vehicle to wait in a parking place during the permitted hours.
- (4) Nothing in the foregoing provisions of this Order shall be taken as authorising anything which would be a contravention of any Regulations made or having effect as if made under Section 25 of the Act of 1984.

Installation of ticket parking meters, placing of traffic signs, etc.

27. The Council shall:

- (a) maintain in good working order the ticket parking meters it has installed;
- (b) cause the limits of each parking place to be indicated on the carriageway by placing and maintaining thereon traffic signs of any size, colour and type prescribed or authorised under Section 64 of the Act of 1984;
- (c) place and maintain in or in the vicinity of each parking place, traffic signs of any size, colour and type, authorised by the Secretary of State, indicating that such parking place may be used during the permitted hours for the leaving only of the vehicle specified in Article 25, and
- (d) carry out such other work as is reasonably required for the purposes of the satisfactory operation of a parking place designated by this Order.

PAY AND DISPLAY PARKING

Tickets to be displayed in vehicles left in pay and display parking places

28. Subject to the provisions of Articles 18 and 31 at all times during which a vehicle is left in a parking place referred to in the Ninth Schedule to this Order during the chargeable hours, the driver shall cause to be displayed a valid ticket so that the date and time of issue and the parking charge paid in respect of the ticket are readily visible from the front or near side of the vehicle.

Amount of the parking charge for ticket parking at parking places

29. The parking charge for a vehicle left in a parking place referred to in the Ninth Schedule to this Order during the chargeable hours shall, subject as hereinafter provided be 20p for the first hour or part thereof and each other hour or part thereof thereafter.

Payment for parking charge and display of ticket issued by ticket parking meter

- 30. Subject to the provisions of Articles 18 and 31:
 - (1) During the chargeable hours, no person shall leave any vehicle in a parking place without having paid the parking charge or without having displayed a ticket issued by a ticket parking meter in accordance with the provisions of this Article.
 - (2) The parking charge shall be payable on the leaving of the vehicle in a parking place by the insertion in a ticket parking meter relating to that parking place of either:
 - (a) a decriminating parking card from which the amount of the parking charge for the parking period for which payment is being made shall be deducted, or
 - (b) a coin or coins of appropriate denominations, as may be identified on the face of the ticket parking meter, together making up the amount of the parking charge for the parking period for which payment is being made.
 - (3) Upon payment of the parking charge for a vehicle left in a parking place, the driver thereof shall display or cause to be displayed on the inside of the vehicle, in accordance with the provisions of the next following paragraph, the ticket issued by the ticket parking meter.
 - (4) The ticket referred to in the preceding paragraph shall be displayed in the "relevant position "on the vehicle in respect of which it was issued at all times during which the vehicle is left during the chargeable hours in the parking place:
 - (5) Provided that for the purposes of this Article, if a vehicle when first placed in a parking bay, is exempt from payment of any charge by virtue of the provisions of Article 18 and continues to wait in that parking bay otherwise than in accordance with those provisions, the parking charge shall be treated as having been incurred and to be payable at the time when the vehicle ceased to wait by virtue of those provisions and all the provisions of the Order shall then apply accordingly.

Exemptions from charges

- 31. (1) If, on the leaving of a vehicle in a parking place during the chargeable hours there is on every ticket parking meter relating to that place a notice placed by any person duly authorised by the Council indicating that the ticket parking meter is out of order, that vehicle shall be exempt from any parking charge provided that, if at least one of the said parking meters is rectified or replaced not later than two hours before the expiration of the chargeable hours, the vehicle is removed within two hours of such rectification or replacement. If the vehicle is not so removed, the parking charge for any parking period of two hours shall be deemed to have been incurred and paid by the insertion of a decriminating parking card or coins for the amount of that parking charge in a ticket parking meter at the time when the vehicle was left in the parking bay and all the provisions of this Order shall apply accordingly.
 - (2) Any disabled person's vehicle which displays in the relevant position a disabled persons badge issued by a local authority or any vehicle which displays a valid permit, for that parking place, issued by the Council shall if left in a parking place during the chargeable hours be exempt from the payment of any charge or compliance with any time limit or prohibited return period in relation to the leaving of any vehicle in that parking place in the foregoing provisions of this Order.
 - (3) A motorcycle left in a parking place or parking bay during the chargeable hours shall be exempt from the payment of any charge or compliance with any time limit or prohibited return period in relation to leaving a vehicle in that parking place or bay prescribed by the foregoing provisions of this Order
 - (4) Without prejudice to the generality of this Article, any vehicle to which this Article applies shall stand in a parking place in accordance with the provisions of Article 7 and wholly within the limits of that parking bay.

SUPPLEMENTARY PROVISIONS

Restriction on the removal of permits and tickets

Where a permit or a ticket has been displayed on a vehicle in accordance with the provisions of Articles 28 or 30(3), no person not being the driver of the vehicle shall remove the permit or ticket from the vehicle unless authorised to do so by the driver.

Indications by ticket parking meter and ticket

- Payment of the parking charge for a vehicle left in a parking place shall be indicated by the issue by a ticket parking meter relating to that parking place of a ticket indicating that a parking charge has been paid, and the day and time by which the parking period for which payment was made by the parking charge will expire, and by the display of that ticket in the manner specified in Article 30(3).
 - (2) The expiry of the parking period for which the parking charge has been paid in respect of a vehicle left in a parking place referred to in the Ninth Schedule to this Order shall be indicated when there is displayed on the vehicle a ticket issued by a ticket parking meter relating to that parking place showing the day and time by which the parking period for which payment was made by the parking charge will expire and the day so shown is not the day on which the vehicle is so left or the time shown on the clock of the said ticket parking meter is later than the time shown on the ticket.

Indications by ticket parking meter and ticket as evidence

- 34. (1) If at any time while a vehicle is left in a parking place during the chargeable hours no ticket issued by a ticket parking meter relating to that parking place is displayed on that vehicle in accordance with the provisions of Article 30 (3), it shall be presumed, unless the contrary is proved, that the parking charge has not been duly paid.
 - (2) If at any time while a vehicle is left in a parking place during the chargeable hours, the ticket issued by a ticket parking meter relating to that parking place and displayed on the vehicle in accordance with the provisions of Article 30 (3) and the clock on the ticket parking meter by which such ticket was issued giving the indication mentioned in Article 33 (2), it shall be presumed, unless the contrary is proved, that the parking charge has been duly paid in respect of that vehicle and the parking period for which payment was made by the parking charge has already expired.
 - (3) Any ticket issued by a ticket parking meter relating to a parking place shall be presumed, unless the contrary is proved, to have been issued on the day shown thereon.

No ticket to be displayed other than that obtained on payment of the parking charge

35. (1) No person shall display on a vehicle left in a parking place during the permitted hours, any ticket issued by a ticket parking meter relating to that parking place other than the ticket issued by such ticket parking meter upon payment of the parking charge in respect of that vehicle until the

expiration of the period of time referred to in Article 33.

(2) No person shall, with intent to deceive, use or lend to, or allow to be used by any other person, any ticket issued by a ticket parking meter to them following their payment of the parking charge in respect of the vehicle.

Power to suspend the use of a parking place

- 36. (1) Any person suspending the use of a parking place or any part thereof in accordance with the provisions of Article 23(1):
 - (a) if the use of the parking place is suspended, place or cause to be placed over or on all the ticket parking meters which relate to that parking place a hood or other cover indicating that the use of the parking place is suspended and that waiting by vehicles is prohibited and place or cause to be placed in or adjacent to that parking place a traffic sign indicating that waiting by vehicles is prohibited; or
 - (b) if the use of any part of the parking place is suspended, place or cause to be placed in or adjacent to that part a traffic sign of the description referred to in the last preceding paragraph.
 - (2) No person shall cause or permit a vehicle to wait:
 - (a) In a parking place during such period as there is over or on all the ticket parking meters relating to that parking place a hood, cover or notice indicating that the use of the parking place is suspended during such period as there is in or adjacent to that parking bay a traffic sign placed in pursuance of paragraph (1) (b) of this Article:
 - (b) in any part of a parking place during such period as there is in or adjacent to that part of the parking place a traffic sign placed in pursuance of paragraph (1) (b) of this Article:

Provided that nothing in this paragraph shall apply:

- (i) in respect of any vehicle being used for fire brigade, ambulance, police or local authority purposes or any vehicle which is waiting for any reason specified in Article 23(1) (b); or
- (ii) to anything done with the permission of the person suspending the use of the

parking place or part thereof in pursuance of Article 23 (1) or a civil enforcement officer in uniform.

PART D

PARKING PERMITS

APPLICATION FOR AND ISSUE OF PERMITS

Application For and Issue Of Permits Under the Council's Parking Permit Scheme

- 37. (a) Any resident whose usual residence is at premises in the length of road specified in the Fourteenth or Fifteenth Schedules to this Order may apply to the Council for the issue of a permit under the terms and conditions of the Council's Parking Permit Scheme for the leaving of a vehicle of the class specified in Article 6 of this Order in the parking place specified in Column 1 of the Seventh Schedule to this Order subject to the provisions of Column 2 of the said Schedule and any such application shall be made on a form issued by and obtainable from the Council and shall include the particulars and information required by such form.
 - (b) Any resident whose usual residence is at premises in the length of road specified in the Fifteenth Schedule to this Order may apply to the Council for the issue of a permit under the terms and conditions of the Council's Parking Permit Scheme for the leaving of a vehicle of the class specified in Article 6 of this Order in the parking place specified in item No's 18 to 21 inclusive of the Ninth Schedule to this Order and any such application shall be made on a form issued by and obtainable from the Council and shall include the particulars and information required by such form.
 - (c) Any person may apply to the Council for the issue of a special permit under the terms and conditions of the Council's Parking Permit Scheme for the leaving of a vehicle of the class specified in Article 6 to this Order in the parking place specified in Column 1 of the Seventh Schedule to this Order and in the parking places item No's 1, 2, 16 and 22 of the Ninth Schedule, and any such application shall be made on a form issued by and obtainable from the Council and shall include the particulars and information required by such a form.
 - (d) The Council may at any time require a permit holder or applicant for a permit to produce to an Officer of the Council such evidence in respect of an application made to them for a permit as they may reasonably require to verify any particulars or information given to them.
 - (e) On receipt of an application duly made under the foregoing provisions of this Article, the Council, upon being satisfied that the applicant is a resident as specified in (a) and (b) of this

Article may subject to provisos (i) and (ii) hereto, issue to the applicant a permit in accordance with the terms and conditions of the Council's Permit Parking Scheme for the leaving in the parking place of a a vehicle to which such permit relates by the consent of the owner, other than a person to whom such vehicle has been let for hire or reward, provided that;

- (i) subject to the provisions of Article 38 of this Order, the Council shall not issue a permit to any resident which would be valid for any period during which any other permit issued to that resident is or would be valid; and
- (ii) provided always that the issue of a permit to a resident shall not be construed as if any parking space in the parking place was reserved solely for the use of that permit holder.
- (f) On receipt of an application duly made under the foregoing provisions of this Article, the Council, upon being satisfied that the applicant is the owner of a vehicle of the class specified in Article 6 of this Order, or the owner of a vehicle requiring a special permit for use in the length of road specified in the Fourteenth or Fifteenth Schedules to this Order, may subject to provisos (i) and (ii) hereto, issue to the applicant one special permit for the leaving in the parking place or for use in the length of road specified the vehicle to which such special permit relates by consent of the owner, other than a person to whom such vehicle has been let for hire or reward, provided that
 - (i) subject to the provisions of Article 39 of this Order, the Council shall not issue a special permit to any person which would be valid for any period during which any other special permit issued to that person is or would be valid, and
 - (ii) provided always that the issue of a special permit to any person shall not be construed as if any parking space is the parking place was reserved solely for the use of the permit holder.
- (h) Nothing in the foregoing paragraphs to this Article shall permit any household to be in receipt of more than the maximum number of parking permits as specified in the Council's Permit Parking Scheme.

Surrender, Withdrawal and Validity Of Permits

38. (a) A permit holder may surrender a permit to the Council at any time and shall surrender a permit to the Council on the occurrence of any one of the events set out in paragraph (c) of this Article.

- (b) (i) The Council may, by notice in writing served on the permit holder by sending the same by recorded delivery service to the permit holder at the address shown by that person on the application for the permit or at any other address believed to be that person's place of abode, withdraw a permit entirely at its own discretion and the permit holder shall surrender the permit to the Council within 48 hours of the receipt of the aforementioned notice,
 - (ii) A permit shall cease to be valid on the occurrence of any one of the events set out in paragraph (c) of this Article.
- (c) The events referred to in the foregoing provisions of this Article are:
 - (a) the permit holder ceasing to be a resident;
 - (b) the permit holder ceasing to be the owner of the vehicle in respect of which the permit was issued;
 - (c) the withdrawal of such permit by the Council under the provisions of paragraph (b) of this Article;
 - (d) the vehicle in respect of which such permit was issued being adapted or used in such a manner that it is not a vehicle of the class specified in Article 6 to this Order.

Application For and Issue Of Duplicate Permits

- 39. (a) If a permit is mutilated or accidentally defaced or the figures or particulars thereon have become illegible or the colour of the permit has become altered by fading or otherwise, the permit holder shall surrender it to the Council and the Council, upon receipt of the permit shall issue a duplicate permit so marked.
 - (b) If the permit is lost or destroyed, the permit holder may apply to the Council for the issue to him of a duplicate permit and the Council, upon being satisfied as to such loss or destruction shall issue a duplicate permit so marked and upon such issue the permit which it duplicates shall become invalid.
 - (c) The provisions of this Order shall apply to a duplicate permit and an application therefore as if it were a permit, or as the case may be, an application therefore.

Display of Permits

40. At all times during which a vehicle is left in a parking place there shall be displayed on the front or near

side of the vehicle a valid parking permit issued in respect of that vehicle so that all the particulars on the face of the permit are readily visible from the front or near side of the vehicle.

Restriction On The Removal of Parking Permits

41. Where a parking permit has been displayed on a vehicle in accordance with the provisions of Article 40 of this Order, no person, not being the driver of the vehicle, shall remove the permit from the vehicle unless authorised to do so by the driver of the vehicle.

<u>PART E</u> GENERAL EXEMPTIONS

Emergency Services

42. Nothing in this Order shall apply to any vehicle on an occasion when it is being used for fire brigade, ambulance or police purposes, if the observance of that provision would be likely to hinder the use of that vehicle for the purpose for which it is being used on that occasion.

Loading and Unloading Goods

- 43. (1) Nothing in this Order shall render it unlawful to cause or permit a vehicle to wait in any parking place which is designated and described in the Sixth, Seventh, Eigth, Ninth, Tenth and Seventeenth Schedules to this Order for so long as may be necessary to enable goods to be loaded onto or unloaded from the vehicle, at any premises fronting onto the parking place provided that no vehicle so engaged shall wait for longer then 30 minutes without the permission of a civil enforcement officer in uniform.
 - (2) Notwithstanding anything in paragraph (1) of this Article the driver of a vehicle waiting for the purposes of delivering or collecting goods or merchandise or loading or unloading the vehicle shall move the vehicle on the instruction of a police constable in uniform or of a PCSO, whenever such moving may be reasonably necessary for the purpose of preventing obstruction.

General

44. (1) Nothing in Part A of this Order shall render it unlawful to cause or permit a vehicle to wait in any part of a designated parking place for so long as may be necessary:-

- (a) to enable a person to board or alight from a vehicle
- (b) to enable a vehicle if it is in the service of a Universal Service Provider to be used for the purposes of delivering or collecting postal packets;
- (c) to enable a vehicle, other than a passenger vehicle, if it cannot be conveniently used for such purpose in any other road, to be used in the service of a local authority or a water authority in pursuance of statutory powers or duties;
- (d) if the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond the control of the driver or to such waiting as is necessary to prevent an accident;
- (e) to enable a vehicle if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the parking place or any part thereof, or the laying, erection, alteration or repair in or near the parking place of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any apparatus as defined in Section 405 the Communications Act 2003 or traffic sign;
- (f) for the purpose of loading or unloading the vehicle while it is in actual use in connection with the removal or delivery of furniture to or from any premises adjacent to a parking place; provided that notice is given 24 hours in advance to the Council's Parking Services and their consent obtained.
- (g) for the purpose of the delivery and collection of bullion to or from any bank or other premises adjacent to a parking place.
- (2) Nothing in Part B of this Order shall render it unlawful to cause or permit a motor cycle to wait in any of the designated parking places specified in the Sixth, Seventh (Item 7) or Ninth Schedules to this Order if the use of that parking place has not been suspended in accordance with the provisions of Article 23 of this Order.
- 46. Nothing in Article 10 of this Order shall render it unlawful to cause or permit a vehicle which displays in the relevant position a disabled person's badge to wait in any of the parking places referred to in the Ninth Schedule to this Order.

PART 4

TRAFFIC MOVEMENT

Prohibition Of Driving

- 47. Save as provided in Article 53 of this Order no person shall except upon the direction of a police constable in uniform or of a PCSO cause or permit any vehicle to proceed in the length of road specified in the Eleventh Schedule to this Order other than a vehicle proceeding between St. George's Sq. car park (Lees Yard) and Crown St on the length of St. George's Sq fronting no.12 St. George's Sq. or a pedal cycle.
- 48. Save as provided in Articles 52 and 53 of this Order no person shall except upon the direction of a police constable in uniform or of a PCSO cause or permit any vehicle other than a pedal cycle to proceed in Bridge Gate between the southern boundary of its junction with St. George's Street and the extension of the northern gable end of No. 16 Bridge Gate.
- 49. Nothing in Article 48 of this Order shall prohibit any person from causing or permitting any vehicle to enter Bridge Gate at its junction with the southern boundary of St. George's Street and proceed only in a southerly direction for the purpose of loading to properties to the southern frontage of St. George's street and in Bridge Gate between its junctions with the southern boundary of St. George's street and the extension of the northern gable of no.16 Bridge Gate including properties on the unnamed road to the side of no.16 Bridge Gate during the hours of 4.00 p.m. to 10.00 a.m..
- 50. (1) Save as provided in Articles 52 and 53 of this Order no person shall except upon the direction or with the permission of a police constable in uniform or of a PCSO cause or permit any vehicle to proceed in the length of road specified in the Sixteenth schedule to this Order unless the vehicle is being driven by or for the purpose of
 - (a) a resident or visitor to households specified in the Fourteenth schedule to this Order, who holds a permit:
 - (b) for the purpose of loading in the length of roads specified in the Sixteenth schedule to this Order.
 - (c) by the holder of a Special Permit permitting access for the purpose of parking to roads

specified in the Sixteenth Schedule to this Order.

- 51. Save as provided in Article 52 of this Order no person shall except upon the direction of a police constable in uniform or of a PCSO cause or permit any vehicle to proceed in an easterly direction along Central Street across the eastern boundary of its junction with Fielding Street.
- 52. Nothing in Articles 48 and 50 of this Order shall apply to the driving of any mechanical road cleansing vehicle when used for that purpose at any time in accordance with any contractual arrangements entered into by the Council for the purpose of the cleansing of the streets.
- 53. Nothing in Articles 47, 48 and 50 of this Order shall prohibit any person from causing or permitting any vehicle to proceed in the length of road specified if the vehicle:
 - (a) is being used for police, ambulance, fire brigade, local authority or water authority purposes when used in pursuance of statutory powers or duties;
 - (b) is being used and cannot conveniently be used for such purposes in any other road for the removal of any obstruction traffic, the maintenance, improvement or reconstruction of the length of road so specified or the laying, erection, alteration or repair in or near the said length of road of any sewer, or of any main, pipe, or apparatus for the supply of gas, water or electricity, or of any apparatus as defined in Section 405 of the Communications Act 2003.

Prohibition Of Turns

- 54. Save as provided for in Article 55 of this Order, no person shall except upon the direction or with the permission of a police constable in uniform or of a PCSO cause or permit any vehicle proceeding in the length of road specified in Column 1 of the Twelfth Schedule to this Order to make a turn into the road specified in Column 2 of the said Schedule.
- 55. Nothing in Article 54 of this Order shall apply if the vehicle is a pedal cycle or vehicle being used for police, fire brigade or ambulance purposes.

One Way Streets

56. Save as provided in Article 57 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or PCSO cause or permit any vehicle to proceed in the length of road specified in Columns 1 and 2 of the Thirteenth Schedule to this Order in a direction other than

that specified in relation to that length of road in Column 3 of the said Schedule.

57. Nothing in Article 56 of this Order shall apply to the driving of any mechanical road cleansing vehicle when used for that purpose at any time in accordance with any contractual arrangements entered into by the Council for the purpose of the cleansing of the streets.

PART 5

REVOCATIONS

58. The Order or Orders specified in Column 1 of the Schedule of Revocations to this Order are hereby revoked to the extent specified in relation thereto in Column 2 of said Schedule.

PART 6

GENERAL

- 59. The restrictions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any Regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.
- 60. For the avoidance of doubt any reference in this Order to a length of road shall be deemed to be a reference to more than one length of road where the context requires it.
- 61. Nothing in the foregoing provisions of this Order shall restrict a Police Constable in uniform from performing his duties if an emergency arises.
- 63. This Order shall come into operation on the 31st March 2008 may be cited as "The Borough Council of Calderdale (Hebden Bridge Central Area) (Controlled Parking Zone) (Consolidation) Order 2008.
