- This Order may be cited as The Borough Council of Calderdale (Waiting and Loading and Parking Places) (Hebden Bridge) (Consolidation) Order 2008 (Variation No. 2) Order 2008 and will come into effect on 7th July 2008
- 2. The Borough Council of Calderdale (Waiting and Loading and Parking Places) (Hebden Bridge) (Consolidation) Order 2008. (hereinafter referred to as "the Order") shall be varied as follows:
 - i) Schedule 7.23 to this Order is to be added to "the Order" and the effect of this will be to restrict Waiting on Sundays & Bank Holidays between 11am-6pm between 01 Mar and 31 Oct
 - ii) The article below is to be inserted into the Order to accommodate the new Schedule 7.23

Save as provided in Articles 72, 73 and 74 of this Order no person shall, except upon the direction or with the permission of a civil enforcement officer in uniform, cause or permit any vehicle to wait on a Sunday or a Bank Holiday between the hours 11am to 6pm 01 March to 31 October inclusive in the length of road specified in Schedule 7.23 to this Order.

iii) Articles 73 and 74 to "the Order" are to be varied as follows:

The words '25 to 46' to be varied to read '25 to 46A'.

The Order specified in Column 1 of the Schedule of Revocations to this
Order are hereby revoked to the extent laid down in Column 2 of the
said Table.

4. Except as hereinbefore provided in this Variation Order the provisions and articles of "the Order" shall remain in force.

The provisions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any Regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.
