The Borough Council of Calderdale in exercise of its powers under Section 1 and 2 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III and Part IV of Schedule 9 to the Act of 1984, hereby makes the following Variation Order to The Borough Council of Calderdale (Waiting and Loading and Parking Places) (Elland) (Consolidation) Order 2008.

- This Order may be cited as The Borough Council of Calderdale (Waiting and Loading and Parking Places) (Elland) (Consolidation) (Variation No. 1) Order 2008 and will come into effect on 26th August 2008.
- 2. The Borough Council of Calderdale (Waiting and Loading and Parking Places) (Elland) (Consolidation) Order 2008. (hereinafter referred to as "the Order") shall be varied as follows:
 - i) the Items in Table A to this Order are to be added to Schedule 5.01 of "the Order" and the effect of this will be to prohibit waiting at any time on the streets listed in the said schedule
 - ii) the Items in Table B to this Order are to be added to Schedule 8.04 of "the Order" and the effect of this will be to limit waiting to 30 minutes (return prohibited within 2 hours) Monday to Saturday 8am 6pm on the streets listed in the said schedule

- The Order specified in Column 1 of Table C of revocations to this Order are hereby revoked to the extent laid down in Column 2 of the said Table.
- 4. Except as hereinbefore provided in this Variation Order the provisions and articles of "the Order" shall remain in force.
- 5. The provisions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any Regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.
