The Borough Council of Calderdale in exercise of its powers under Section 1, 2, 32, 35, 45, 46, 49, 51 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Variation Order to The Borough Council Of Calderdale (Halifax) (Controlled Parking Zone) Consolidation Order 2008.

1. This Order may be cited as The Borough Council Of Calderdale (Halifax) (Controlled Parking Zone) Consolidation Order 2008 (Variation No. 1) Order 2008 and will come into effect on 2nd March 2009.

2. The Borough Council Of Calderdale (Hebden Bridge) (Controlled Parking Zone) Consolidation Order 2008 (hereinafter referred to as "the Order") shall be varied as follows: -
 - i) the items in table A to this Order are to be added to Schedule 3.01 of "the Order" and the effect of this would be to restrict waiting and loading at any time on the streets listed in the said Schedule,

 - (ii) the items in table B to this Order are to be added to Schedule 10.13 of "the Order" and the effect of this would be to introduce pay and display one hour return prohibited within one hour Mon – sat 8am – 6pm Free without time limit at other times on the streets listed in the said Schedule.

 - (iii) the items in table C to this Order are to be added to Schedule 10.14 of "the Order" and the effect of this would be to introduce pay and display 2 hours return prohibited within one hour Mon – sat 8am – 6pm Free without time limit at other times on the streets listed in the said Schedule.;

(iv) the items in table D to this Order are to be added to Schedule 12.01 of “the Order” and the effect of this would be to introduce disabled parking all days all hours on the streets listed in the said Schedule,

(v) the items in table E to this Order are to be added to Schedule 12.07 of “the Order” and the effect of this would be to introduce disabled parking 2 hours return prohibited within 1 hour on the streets listed in the said Schedule.

(vi) the items in table F to this Order are to be added to Schedule 14.02 of “the Order” and the effect of this would be to limit loading to 30 minutes return prohibited within 1 hour on the streets listed in the said Schedule,

3. The Orders specified in Column 1 of the Schedule of revocations to this Order are hereby revoked to the extent laid down in Column 2 of the said table
4. Except as hereinbefore provided in this Variation Order the provisions and articles of “the Order” shall remain in force.
5. The provisions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any Regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.
