 i) the items in Table A to "this Order" are to be added to Schedule 6.04 of "the Order" and the effect of this will be to prohibit waiting Mon-Fri 8.15-9.15am and 2.30-4pm No Loading Mon-Fri 8.15-9.15am and 2.30-4pm on the streets listed in the said schedule.

- ii) the items in Table B to "this Order" are to be added to Schedule 15.01of "the Order" and the effect of this will be to prevent stopping on the School Clearway <u>Mon-Fri 8.15-9.15am and 2.30-</u> <u>4pm</u>
- iii) The Schedules in the Schedule of Revocations to this Order are to be revoked to the extent laid down in column 2

- 3. Except as hereinbefore provided in this Variation Order the provisions and articles of "the Order" shall remain in force.
- 4. The provisions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any Regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.
