- This Order may be cited as The Borough Council of Calderdale (Waiting and Loading and Parking Places) (Brighouse) (Consolidation) Order 2008 (Variation No. 6) Order 2008 and will come into effect on 4th May 2009.
- 2. The Borough Council of Calderdale (Waiting and Loading and Parking Places)

 (Brighouse) (Consolidation) Order 2008. (hereinafter referred to as "the Order") shall be varied as follows: -
 - I) the Items in Table A to this Order are to be added to Schedule 5.01 of "the Order" and the effect of this will be to restrict waiting at any time on the streets listed in the said schedule
 - ii) the Items in Table A to this Order are to be added to Schedule 15.01 of "the Order" and the effect of this will be to restrict stopping on the school clearway on Monday to Friday 8.15-9.15am and 2.30-4pm on the streets listed in the said schedule
- 3. Except as hereinbefore provided in this Variation Order the provisions and articles of "the Order" shall remain in force.

4. The provisions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any Regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.
