- This Order may be cited as The Borough Council of Calderdale (Waiting and Loading and Parking Places) (Halifax) (Consolidation) Order 2008 (Variation No. 1)
 Order 2009 and will come into effect on 23rd May 2009
- 2. The Borough Council of Calderdale (Waiting and Loading and Parking Places)

 (Halifax) (Consolidation) Order 2008. (hereinafter referred to as "the Order") shall be varied as follows:
 - i) The Items in Table A to this Order are to be added to Schedule 5.01 of "the Order" and the effect of this will be to prohibit waiting at any time on Birdcage Lane, Kensington Road and Lister Street to the extent listed in the schedule.
 - ii) The Items in Table B to this Order are to be added to Schedule 7.01 of "the Order" and the effect of this will be to prohibit waiting Mon Fri 8.00am 6.00pm on Lister Street to the extent listed in the schedule.
 - iii) The Items in Table C to this Order are to be added as Schedule 10.11 of "the Order" and the effect of this will be to introduce Resident Parking all days all hours or Pay and Display 2 hours return prohibited within 2 hours Mon-Sat 8am-6pm as detailed in the schedule.

3. The Order specified in Column 1 of the Table D "Schedule of revocations" to this Order are hereby revoked to the extent laid down in Column 2 of the said Table.

- 4. Except as hereinbefore provided in this Variation Order the provisions and articles of "the Order" shall remain in force.
- 5. The provisions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any Regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.
