The Borough Council of Calderdale in exercise of its powers under Section 1, 2, 32, 35, 45, 46, 49, 51 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III and Part IV of Schedule 9 to the Act of 1984, hereby makes the following Variation Order to The Borough Council of Calderdale (Waiting and Loading and Parking Places) (Brighouse) (Consolidation) Order 2008.

1. This Order may be cited as The Borough Council of Calderdale (Waiting and Loading and Parking Places) (Brighouse) (Consolidation) Order 2008 (Variation No. 1) Order 2009 and will come into effect on Monday 18<sup>th</sup> May 2009
  
2. The Borough Council of Calderdale (Waiting and Loading and Parking Places) (Brighouse) (Consolidation) Order 2008. (hereinafter referred to as "the Order") shall be varied as follows: -
  - i) the Items in Table A to this Order are to be added to Schedule 5.01 of "the Order" and the effect of this will be to prohibit waiting at any time on the streets listed in the said schedule
  
3. Except as hereinbefore provided in this Variation Order the provisions and articles of "the Order" shall remain in force.

4. The provisions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any Regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

**Schedule 5.01 to "the Order"**

<u>Item</u>	<u>Column 1 Road</u>	<u>Column 2 Extent</u>
1	A58 Halifax Road, Hipperholme	The north side from a point approximately 6 metres east of its intersection with the projected south eastern kerbline of Kirk Lane in a westerly direction for a distance of approximately 18 metres.
2	Kirk Lane, Hipperholme	Both sides from its junction with A58 Halifax Road in a north-easterly direction to its junction with lane Ends Green
3.	Lane Ends Green, Hipperholme	The south west side from a point approximately 7.6 metres south east of its intersection with the projected south eastern kerbline of Kirk Lane (Lane Ends Green to A58 Halifax Road) in a north westerly direction for a distance of approximately 19 metres.
