The Borough Council of Calderdale in exercise of its powers under Sections 1, 2, 4, 32, 35, 45, 46, 47, 53 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III and Part IV of Schedule 9 to the Act of 1984, hereby makes the following Variation Order to The Borough Council of Calderdale (Waiting and Loading and Parking Places) (Halifax) (Consolidation) Order 2009.

- This Order may be cited as The Borough Council of Calderdale (Waiting and Loading and Parking Places) (Halifax) (Consolidation) Order 2008 (Variation No. 5) Order 2009 and will come into effect on Monday 22nd February 2010
- The Borough Council of Calderdale (Waiting and Loading and Parking Places) (Halifax) (Consolidation) Order 2008. (hereinafter referred to as "the Order") shall be varied as follows: -

i) The Items in Table A to this Order are to be added to Schedule 4.04 of "the Order "and the effect of this will be to prohibit waiting at any time and No Loading Mon-Fri 8.15am-9.15am and 2.30pm-4pm on the streets named in this Order.

ii) The Items in Table B to this Order are to be added to Schedule 5.01 of "the Order" and the effect of this will be to prohibit waiting at any time on the streets named in this Order.

iii) The Items in Table C to this Order are to be added to Schedule 6.04 of "the Order" and the effect of this will be to prohibit waiting and Loading Mon-Fri 8.15am-9.15am and 2.30pm-4pm on the streets named in this Order.

iv) The Items in Table D to this Order are to be added to Schedule 8.03 of "the Order" and the effect of this will be to Limited Waiting to 2 hours return prohibited within 2 hours Mon-Sat 8am-6pm on the streets named in this Order

v) The Items in Table E to this Order are to be added to Schedule 15.01 of "the Order" and the effect of this will be to create a School Clearway (No Stopping on

School Keep Clear) Mon-Fri 8.15am-9.15am and 2.30pm-4pm on the streets named in this Order

ii) The Schedules in Table F are the Schedule of Revocations to this Order and are to be revoked to the extent laid down in column 2

- 3. Except as hereinbefore provided in this Variation Order the provisions and articles of "the Order" shall remain in force.
- 4. The provisions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any Regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.
