The Borough Council of Calderdale in exercise of its powers under Section 1, 2, 32, 35, 45, 46, 49, 51 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III and Part IV of Schedule 9 to the Act of 1984, hereby makes the following Variation Order to The Borough Council of Calderdale (Waiting and Loading and Parking Places) (Brighouse) (Consolidation) Order 2008.

1. This Order may be cited as The Borough Council of Calderdale (Waiting and Loading and Parking Places) (Brighouse) (Consolidation) Order 2008 (Variation No. 1) Order 2010 and will come into effect on 23 August 2010.
2. The Borough Council of Calderdale (Waiting and Loading and Parking Places) (Brighouse) (Consolidation) Order 2008. (hereinafter referred to as "the Order") shall be varied as follows: -

The following Articles are to be added to "the Order"

Additional Articles

Limited Waiting Monday to Saturday 8am – 6pm – waiting limited to 1 hour return prohibited within 1 hour No licensed private hire vehicles
(Schedule 8.25)

- 70A (1) Save as provided in Articles 72 and 74 of this Order no person shall, except upon the direction or with the permission of a civil enforcement officer in uniform, cause or permit any vehicle, excluding licensed private hire vehicles, to wait between the hours of 8am to 6pm Monday to Saturday in the length of road specified in Schedule 8.25 to this Order unless such day falls upon a Bank Holiday

- (a) for a period longer than 1 hour or
- (b) if a period of less than 1 hour has elapsed since the termination during the said hours of the last period of waiting (if any) by that vehicle on the same side or length of road.

(2) No person shall, except upon the direction or with the permission of a civil enforcement officer in uniform, cause or permit any licensed private hire vehicle to wait between the hours 8am to 6pm Monday to Saturday in the length of road specified in Schedule 8.25 to this Order.

Limited Waiting Monday to Saturday 8am – 6pm – waiting limited to 15 minutes return prohibited within 1 hour No licensed private hire vehicles

(Schedule 8.26)

70B(1) Save as provided in Articles 72 and 74 of this Order no person shall, except upon the direction or with the permission of a civil enforcement officer in uniform, cause or permit any vehicle, excluding licensed private hire vehicles, to wait between the hours of 8am to 6pm Monday to Saturday in the length of road specified in Schedule 8.26 to this Order unless such day falls upon a Bank Holiday

- (a) for a period longer than 15 minutes or
- (b) if a period of less than 1 hour has elapsed since the termination during the said hours of the last period of waiting (if any) by that vehicle on the same side or length of road.

(2) No person shall, except upon the direction or with the permission of a civil enforcement officer in uniform, cause or permit any licensed private hire vehicle to wait between the hours 8am to 6pm Monday to Saturday in the length of road specified in Schedule 8.26 to this Order.

Additional Schedules

- i) the Items in Table A to this Order are to be added to Schedule 8.25 of “the Order” and the effect of this will be to Limit Waiting to 1 hour return prohibited within 1 hour Mon-Sat 8am-6pm - No licensed private hire vehicles on the streets listed in the said schedule
- ii) the Items in Table B to this Order are to be added to Schedule 8.26 of “the Order” and the effect of this will be to Limit Waiting to 15 minutes return prohibited within 1 hour Mon-Sat 8am-6pm - No licensed private hire vehicles on the streets listed in the said schedule
- iii) the items in Table C to this Order are to be added to Schedule 9.02 of “the Order” and the effect of this will be to introduce a Parking Place 1 hour return prohibited within 1 hour Mon-Sat 8am-6pm - No licensed private hire vehicles on the streets listed in the said schedule

- iv) The Schedules in Table D are the Schedule of Revocations to this Order and are to be revoked to the extent laid down in column 2
3. Except as hereinbefore provided in this Variation Order the provisions and articles of "the Order" shall remain in force.
4. The provisions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any Regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

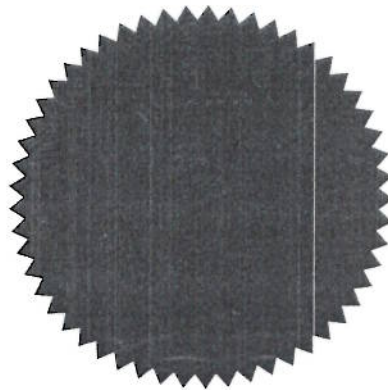
