

The Borough Council of Calderdale in exercise of its powers under Section 1 and 2 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III and Part IV of Schedule 9 to the Act of 1984, hereby makes the following Variation Order to The Borough Council of Calderdale (Waiting and Loading and Parking Places) (Halifax) (Consolidation) Order 2008.

1. This Order may be cited as The Borough Council of Calderdale (Waiting and Loading and Parking Places) (Halifax) (Consolidation) Order 2008 (Variation No. 1) Order 2010 and will come into operation on 06 September 2010.
2. The Borough Council of Calderdale (Halifax) (Consolidation) Order 2008 (hereinafter referred to as "the Order") shall be varied as follows:-
 - i. The items in Table A to this Order are to be added to Schedule 5.01 of the Order and the effect of this will be to prohibit waiting at any time on the streets listed in the said schedule
 - ii. The items in Table B to this Order are to be added to Schedule 7.02 of the Order and the effect of this will be to prohibit waiting at any time Monday to Friday 8am – 6pm on the street listed in the said schedule.
 - iii. The Schedules listed in Table C to this Order are the Schedule of Revocations to the Order and are to be revoked to the extent laid down in Column 2.

3. Except as hereinbefore provided in this Variation Order the provisions and articles of "the Order" shall remain in force.
4. The provisions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any Regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

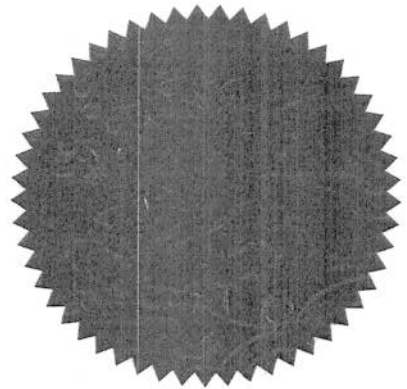

1	Haugh Shaw Road West	<p>the east & south-east side from its intersection with the projected south-eastern kerblines of King Cross Road in a south-easterly then south-westerly direction for a distance of approximately 82 metres.</p> <p>the south-east side from a point approximately 106 metres in a south-easterly then south-westerly direction from its intersection with the south-eastern kerblines of King Cross Road in a south-westerly direction to a point approximately 6 metres north-east of the intersection of its southern and south-eastern kerb lines, a distance of approximately 130 metres.</p> <p>the west & north-west side from its junction with the south-eastern kerblines of King Cross Road in a south-easterly then south-westerly direction, including the turning head at Tatham's Court, to a point approximately 6 metres north of the intersection of its western and southern kerb lines at its western terminal end, a distance of approximately 274 metres</p>
