The Borough Council of Calderdale in exercise of its powers under Sections 1, 2, 4, 32, 35, 45, 46, 47, 53 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III and Part IV of Schedule 9 to the Act of 1984, hereby makes the following Variation Order to The Borough Council of Calderdale (Waiting and Loading and Parking Places) (Halifax) (Consolidation) Order 2008.

1. This Order may be cited as The Borough Council of Calderdale (Waiting and Loading and Parking Places) (Halifax) (Consolidation) Order 2008 (Variation No. 3) Order 2009 and will come into effect on 20 September 2010.
2. The Borough Council of Calderdale (Waiting and Loading and Parking Places) (Halifax) (Consolidation) Order 2008. (hereinafter referred to as "the Order") shall be varied as follows: -
 - i) The Items in Table A to this Order are to be added to Schedule 5.01 of "the Order" and the effect of this will be to prohibit waiting at any time on the streets named in the First Schedule of this Order.
 - ii) The Schedules in the Schedule of Revocations to this Order are to be revoked to the extent laid down in column 2
3. Except as hereinbefore provided in this Variation Order the provisions and articles of "the Order" shall remain in force.

4. The provisions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any Regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

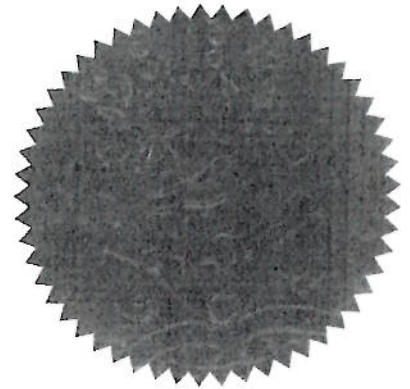
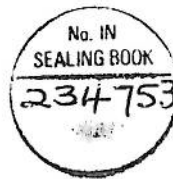

1	Back Ned Hill Road	<p>the north-east side from its junction with Syke Lane in a south-easterly direction for a distance of approximately 36 metres.</p> <p>the south-west side from its junction with Syke Lane in a south-easterly direction for a distance of approximately 18 metres.</p>
2	Keighley Road (A629)	<p>both sides from a point approximately 196 metres north of the projected northern kerbline of Ogden Lane in a southerly direction for a distance of approximately 399 metres.</p>
3	Syke Lane	<p>the north-east side from its intersection with the projected eastern kerbline of Keighley Road (A629) in a south-easterly direction for a distance of approximately 35 metres.</p> <p>the north-east side from a point approximately 62 metres south-east of its junction with the projected eastern kerbline of Keighley Road (A629) in a south-easterly direction for a distance of approximately 234 metres.</p> <p>the south-west side from its junction with the projected eastern kerbline of Keighley Road (A629) in a south-easterly direction for a distance of approximately 335 metres.</p>
