The Borough Council of Calderdale in exercise of its powers under Section 1, 2, 4, and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III and Part IV of Schedule 9 to the Act of 1984, hereby makes the following Variation Order to The Borough Council of Calderdale (Waiting and Loading and Parking Places) (Elland) (Consolidation) Order 2008.

- This Order may be cited as The Borough Council of Calderdale (Waiting and Loading and Parking Places) (Elland) (Consolidation) Order 2008 (Variation No. 1)
 Order 2012 and will come into operation on 8th October 2012.
- 2. The Borough Council of Calderdale (Elland) (Consolidation) Order 2008 (hereinafter referred to as "the Order") shall be varied as follows:
 - i. The items in Table A to this Order are to be added to Schedule 5.01 of the Order and the effect of this will be no waiting at any time on the streets listed in the said Schedule
 - ii. The following text shall be added to Part 1, General, Interpretation, paragraph 2.2 of the Order:

"relevant position" in relation to the display of a permit means, in the case of a vehicle with a front windscreen, the permit is exhibited thereon facing outwards on the near side of and immediately behind the windscreen; or in the case of a vehicle not fitted with a front windscreen, the permit is exhibited in a conspicuous position on the motor vehicle.

- 3. Except as hereinbefore provided in this Variation Order the provisions and articles of "the Order" shall remain in force.
- 4. The provisions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any Regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.





A copy of the Order, which was made on 3rd October 2012 and will come into effect on 8th October 2012, together with a map may be inspected during normal office hours at the offices of the Head of Planning and Highways at Northgate House, Northgate, Halifax.

If you wish to question the validity of the Order or of any of its provisions on the ground that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or, that any requirement of that Act or any instrument made under it has not been complied with in relation to the Order, you may within 6 weeks from the date on which the Order was made apply to the High Court for this purpose.
