The Borough Council of Calderdale in exercise of its powers under Section 1, 2, 4, 32, 35, 45, 46, 47, 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order to vary The Borough Council of Calderdale (Waiting and Loading and Parking Places) (Elland) (Consolidation) Order 2008.

1. This Order may be cited as The Borough Council of Calderdale (Waiting and Loading and Parking Places) (Elland) (Consolidation) Order 2008 (Variation No.2) Order 2022 (hereinafter referred to as the "Variation Order") is made this 4th day of May 2022 and will come into effect on 4th June 2022.
2. The Borough Council of Calderdale (Waiting and Loading and Parking Places) (Elland) (Consolidation) Order 2008 (hereinafter referred to as "the Consolidation Order") shall be varied as follows:-
 - i. The Items in Table A to this Variation Order are added to Schedule 5.01 of the Consolidation Order.
 - ii. The Items in Table B to this Variation Order as implemented into the Consolidation Order shall hereby be revoked to the extent so specified in said Table.
3. Except as hereinbefore provided in this Variation Order the provisions and articles of the Consolidation Order shall remain in force.
4. The provisions imposed by this Variation Order are in addition to and not in derogation of any restrictions or requirements imposed by any Regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

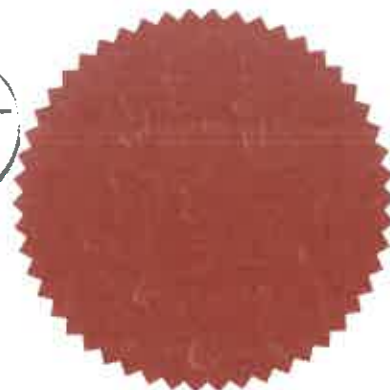
