The Borough Council of Calderdale in exercise of its powers under Sections 32, 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III and Part IV of Schedule 9 to the Act of 1984, hereby makes the following variation to The Borough Council of Calderdale (Off Street Parking Places) (Consolidation) Order 2013 Halifax Car Parks.

- 1. This Order may be cited as The Borough Council of Calderdale (Off Street Parking Places) (Consolidation) Order 2013 (Variation No 1) 2017 Halifax Car Parks and will come into effect on 18th December 2017 and will remain in force until 18th May 2018.
- 2. The Borough Council of Calderdale (Off Street Parking Places) (Consolidation) Order 2013 Halifax Car Parks (hereinafter referred to as "the Consolidation Order") shall be varied as follows: -
 - 2.1 The Item in Table A to this Order is to be added to Schedule 1 of the Consolidation Order.
 - 2.2 The Item in Table B of this Order as implemented into the Consolidation Order shall hereby be revoked.
- 3. Except as hereinbefore provided in this Order the provisions and articles of the Consolidation Order as amended shall remain in force.
- 4. The provisions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any Regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.
