

The Borough Council of Calderdale in exercise of its powers under Section 1, 2, 32, 35, 45, 46, 49, 51 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III and Part IV of Schedule 9 to the Act of 1984, hereby makes the following variation to The Borough Council of Calderdale (Waiting and Loading and Parking Places) (Sowerby Bridge) (Consolidation) Order 2008.

1. This Order may be cited as The Borough Council of Calderdale (Waiting and Loading and Parking Places) (Sowerby Bridge) (Consolidation) Order 2008 (Variation No. 1) Order 2016 (Part A) and will come into effect on 15<sup>th</sup> January 2018.
2. The Borough Council of Calderdale (Waiting and Loading and Parking Places) (Sowerby Bridge) (Consolidation) Order 2008 (hereinafter referred to as "the Consolidation Order") shall be varied as follows: -
  - 2.1 The Items in Table A of this Order are to be added to Schedule 5.01 of the Consolidation Order and the effect of this will be  
(i) no waiting at any time on the lengths of street listed in the said table.
  - 2.2 The Items in Table B of this Order as implemented into the Consolidation Order shall hereby be revoked.
3. Except as hereinbefore provided in this Order the provisions and articles of the Consolidation Order as amended shall remain in force.
4. The provisions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any Regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.
