The Borough Council of Calderdale in exercise of its powers under Section 1, 2, 32, 35, 45, 46, 49, 51 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III and Part IV of Schedule 9 to the Act of 1984, hereby makes the following Order (hereinafter referred to as the "Variation Order" to vary The Borough Council of Calderdale (Waiting and Loading and Parking Places) (Halifax) (Consolidation) Order 2015.

1. This Variation Order is made on this 26th day of August 2020 and shall come into operation on 7th September 2020 and may be cited as The Borough Council of Calderdale (Waiting and Loading and Parking Places) (Halifax) (Consolidation) Order 2015 (Variation No. 5) Order 2020.
2. The Borough Council of Calderdale (Waiting and Loading and Parking Places) (Halifax) (Consolidation) Order 2015 (hereinafter referred to as "the Consolidation Order") shall be varied as follows: -
 - 2.1 The Items in Table A to this Variation Order are to be added to Schedule 5.01 of the Consolidation Order; and
 - 2.2 The Items in Table B of this Order as implemented into the Consolidation Order are hereby revoked.
3. Except as hereinbefore provided in this Variation Order the provisions and articles of the Consolidation Order as amended shall remain in force.
4. The provisions imposed by this Variation Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any Regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

1	Copley Lane	the north side – from a point 7 metres north east of its junction with the projected eastern kerbline of Riverwood Drive in a north easterly direction for a distance of 46 metres
2	Falcon Street	the north west side - from its junction with Chapel Lane in a north easterly direction for a distance of 30 metres
3	Shaw Lane	both sides – from its junction with Shaw Hill Lane in a south easterly direction for a distance of approximately 55 metres (measured along its centre line) both sides – from a point approximately 74 metres south east of its junction with Shaw Hill Lane in a south easterly direction for a distance of 14 metres (measured along its centre line)
4	Springwood Drive	the north east side – from its junction with the projected northern kerbline of Copley Lane in a north westerly direction for a distance of approximately 30 metres the south west side – from its junction with the projected northern kerbline of Copley Lane in a north westerly direction for a distance of approximately 14 metres
