
The Borough Council of Calderdale in exercise of its powers under Section 1, 2, 4, 32, 35, 45, 46, 47, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order to vary The Borough Council of Calderdale (Waiting and Loading and Parking Places) (Sowerby Bridge) (Consolidation) Order 2008.

1. This Order may be cited as The Borough Council of Calderdale (Waiting and Loading and Parking Places) (Sowerby Bridge) (Consolidation) Order 2008 (Variation No.1) Order 2021 (Part B) (hereinafter referred to as the "Variation Order") and is made this 30<sup>th</sup> day of March 2022 and will come into effect on 11<sup>th</sup> day of April 2022.
2. The Borough Council of Calderdale (Waiting and Loading and Parking Places) (Sowerby Bridge) (Consolidation) Order 2008 (hereinafter referred to as "the Consolidated Order") shall be varied as follows:-
  - i. The Items in Table A to this Variation Order are added to Schedule 5.01 of the Consolidation Order.
  - ii. Table B to this Variation Order is added as Schedule 7.23 of the Consolidation Order.
  - iii. The following wording shall be added to the Consolidation Order as Article 46A:  
"No Waiting Monday to Friday 9.00am to 10.00am and 2.00pm to 3.00pm (Schedule 7.23)  
46A Save as provided in Articles 72, 73 and 74 of this Order no person shall, except upon the direction or with the permission of a civil enforcement officer in uniform, cause or permit any vehicle to wait between the hours of 9.00am to 10.00am and 2.00pm to 3.00pm Monday to Friday inclusive in the lengths of road specified in Schedule 7.23 of this Order.

- iv. In Article 73 of the Consolidation Order the words "46A" shall be inserted after "46".
  - v. In Article 74 of the Consolidation Order the words "46A" shall be inserted after "46".
3. Except as hereinbefore provided in this Variation Order the provisions and articles of the Consolidation Order shall remain in force.
4. The provisions imposed by this Variation Order are in addition to and not in derogation of any restrictions or requirements imposed by any Regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.
