The Borough Council of Calderdale in exercise of its powers under Section 1, 2, 4, 32, 35, 45, 46, 47, 49, 51 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order (hereinafter referred to as "the Variation Order") to vary The Borough Council of Calderdale (Waiting and Loading and Parking Places) (Todmorden) (Consolidation) Order 2008.

1. This Variation Order is made the 20<sup>th</sup> day of January 2021 and may be cited as "The Borough Council of Calderdale (Waiting and Loading and Parking Places) (Todmorden) (Consolidation) Order 2008 (Variation No. 3) Order 2020" and will come into operation on 1<sup>st</sup> February 2021.
2. The Borough Council of Calderdale (Waiting Loading and Parking Places) (Todmorden) (Consolidation) Order 2008 (hereinafter referred to as "the Consolidation Order") shall be varied as follows:-
  - i. The items in Table A to this Variation Order are to be added to Schedule 8.14 of the Consolidation Order and the effect of this will be limited waiting for one hour (no return within one hour) Mondays to Saturdays 8am to 6pm on the streets listed in the said Schedule.

- ii. The schedules and items listed in Column 2 of Table B to this Variation Order as implemented into the Consolidation Order are hereby revoked to the extent laid down in Column 2.
3. Except as hereinbefore provided in this Variation Order the provisions and articles of the Consolidation Order shall remain in force.
4. The provisions imposed by this Variation Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any Regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

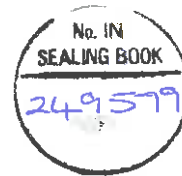
