The Borough Council of Calderdale in exercise of its powers under Section 32, 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following variation order.

1. This Order (hereinafter referred to as "the Variation Order") is made 24 July 2024 may be cited as "The Borough Council of Calderdale (Car Parks) Consolidation Order 2019 (Variation No.1) Order 2024" and will come into operation on 12 August 2024
2. The Borough Council of Calderdale (Car Parks) Consolidation Order 2019 (hereinafter referred to as "the Original Order") shall be varied as follows:-
  - i. The plan attached to this Variation Order shall be attached to the Original Order.
  - ii. The items in Table A to this Variation Order are added to Schedule 1 of the Original Order.
3. Except as hereinbefore provided in this Variation Order the provisions and articles of the Original Order shall remain in force.
4. The provisions imposed by this Variation Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any Regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.
