Parking and Special Parking Places) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2004 and any reference to the Order of 2004 shall be construed as a reference to that Order as varied or amended.
- DURING the period this Order remains in force the Order of 2004 shall be amended and have 3. effect as though plan no. J21 insofar as it affects Guildhall Street was deleted and substituted by the plan annexed to this Order.
- The Deputy Chief Executive of Environment and Community Services of the Cambridgeshire 4. County Council or a person authorised by him may pursuant to and subject to Section 10 of the Act modify or suspend the operation of the whole of this order or any provision in it if it appears to him essential
 - in the interests of expeditious, convenient and safe movement of (a)
 - in the interests of providing suitable and adequate on street (b) parking facilities;
 - for preserving or improving the amenities of the area through (c) which any road affected by the Order runs
