**THE CITY OF CAMBRIDGE (CIVIL ENFORCEMENT AREA)  
(WAITING RESTRICTIONS AND STREET PARKING PLACES) ORDER 2008  
(AMENDMENT NO. 21) ORDER 2010**

Cambridgeshire County Council in exercise of its powers under Sections 1, 2, 3, 4, 32, 35, 64 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and with the Traffic Management Act 2004 Part 6 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. This Order shall come into operation for all purposes on the 28th day of June 2010 and may be cited as The City of Cambridge (Civil Enforcement Area)(Waiting Restrictions and Street Parking Places) Order 2008 (Amendment No. 21) Order 2010.
2. In this Order the expression "the Order of 2008" shall mean The City of Cambridge (Civil Enforcement Area)(Waiting Restrictions and Street Parking Places) Order 2008 and any reference to the Order of 2008 shall be construed as a reference to that Order as varied or amended.
3. The Order of 2008 shall be amended and have effect as though plans nos. J16 and M18 were deleted and substituted by the plans annexed to this Order.

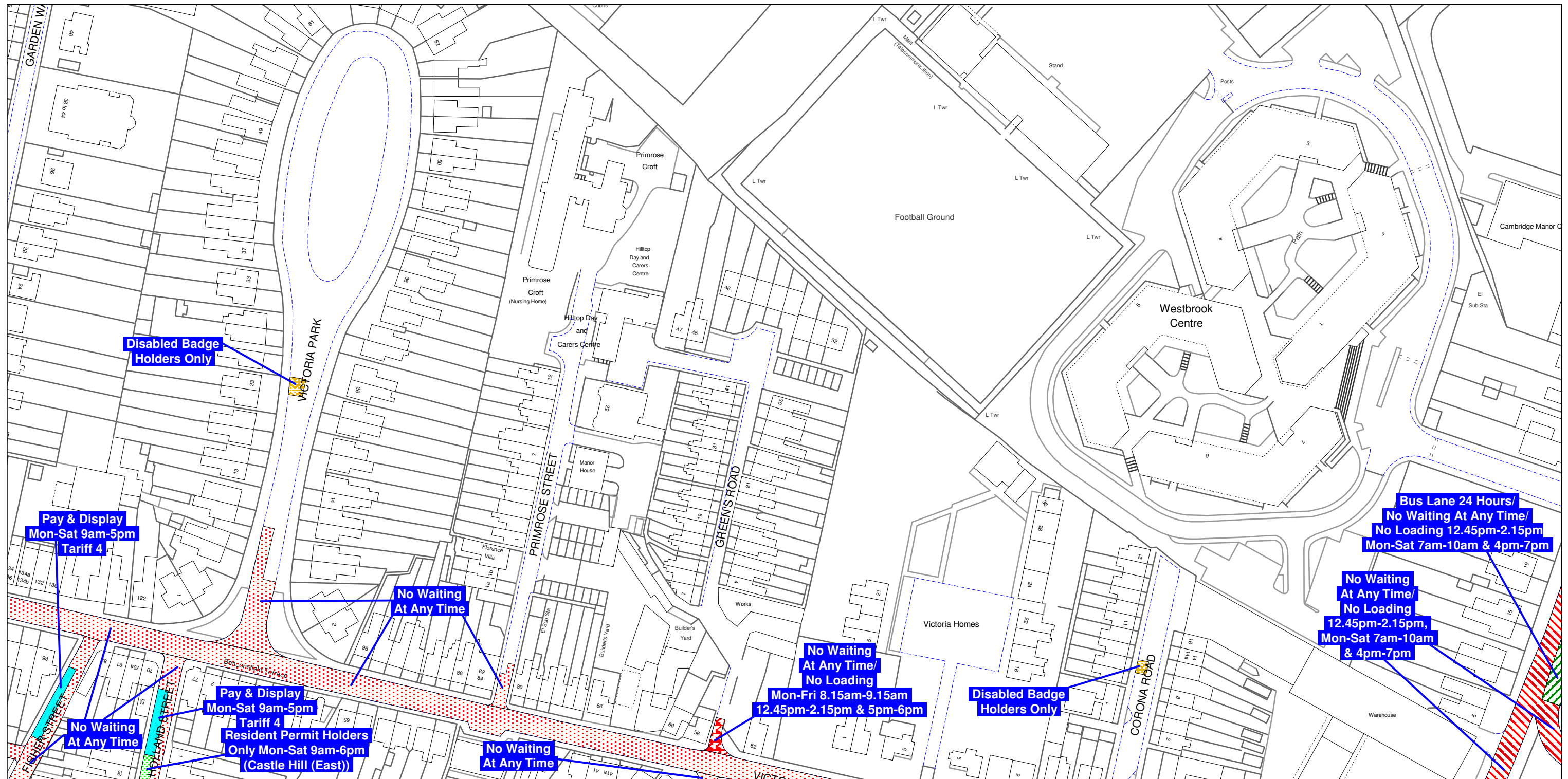

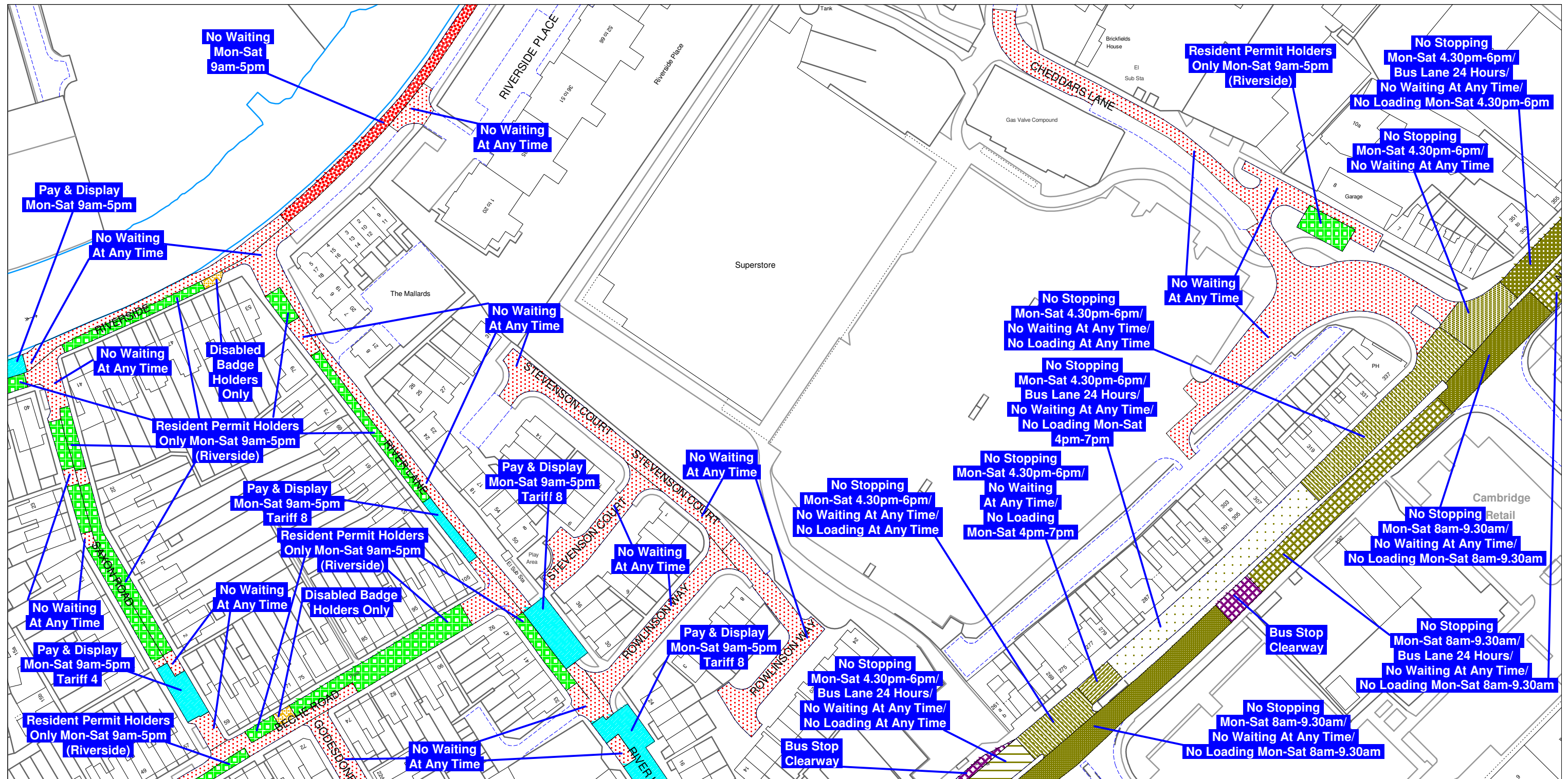
