**THE CITY OF CAMBRIDGE (CIVIL ENFORCEMENT AREA)  
(WAITING RESTRICTIONS AND STREET PARKING PLACES) ORDER 2008  
(AMENDMENT NO. 09) ORDER 2009**

Cambridgeshire County Council in exercise of its powers under Sections 1, 2, 3, 4, 19, 32, 35, 45, 46, 47, 61, 63, 64 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and with the Traffic Management Act 2004 Part 6 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

Cambridgeshire County Council ("The Council") in exercise of its powers under Sections 1, 2, 3, 4, 19, 32, 35, 45, 46, 49, 63, and 64 of the Road Traffic Regulation Act 1984 ("the Act of 1984") (as amended) and with the Road Traffic Act 1991 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby make the following Order:

1. This Order shall come into operation for all purposes on the 19th day of October 2009 and may be cited as The City of Cambridge (Civil Enforcement Area)(Waiting Restrictions and Street Parking Places) Order 2008 (Amendment No. 09) Order 2009.
2. In this Order the expression "the Order of 2008" shall mean The City of Cambridge (Civil Enforcement Area)(Waiting Restrictions and Street Parking Places) Order 2008 and any reference to the Order of 2008 shall be construed as a reference to that Order as varied or amended.
3. The Order of 2008 shall be amended and have effect as though plan no. M20 was deleted and substituted by the plan annexed to this Order.
