Notice is hereby given that KENT COUNTY COUNCIL has made the above Order under sections 1(1), 2(1) to (3), 3(2), 4(1) and (2) of the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act.

The effect of the Order is to amend the Kent County Council (Various Roads, City of Canterbury) (Prohibition of Stopping on Footway or Verge) (Consolidation) Order 2013 by introducing new or varying existing parking and waiting restrictions on the following lengths of road:

Knight Avenue, Canterbury Pavement Parking Ban between the junctions with Rheims Way

and Miller Avenue

Whitstable Road, Canterbury Pavement Parking Ban

St Stephens Hill area, Canterbury Pavement Parking Bans in St Stephen's Hill, Shaftesbury

Road, Leycroft Close and Stephenson Road

Canterbury Road, Herne Bay

Pavement Parking Ban outside the shops between King's

Road & Gosfield Road

The order was made on 25th July 2013 and comes into force on 29th July 2013. Full details are contained in the Order which, together with a Statement of the Council's reasons for making the Order and a copy of the orders amended by the Order may be examined at the Canterbury City Council offices, Military Road, Canterbury, CT1 1YW during normal office hours.

Any person wishing to question the validity of the Order or any of the provisions contained therein on the grounds that it is not within the powers of the relevant enabling Act or that any requirement of any such enabling Act or of any regulations made thereunder have not been complied with may within 6 weeks from the date on which the Order was made make application to the High Court for this purpose.
