Notice is hereby given that KENT COUNTY COUNCIL has made the above Order under sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 45, 46, 49 and 53 of the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act:

The effect of the Order is to amend the Kent County Council (Canterbury Rural Parishes) (Traffic Regulation and Street Parking Places) (Consolidation) Order 2012 by introducing new or varying existing parking and waiting restrictions on the following lengths of road in rural parishes in the Canterbury district:

Risdon Close, Sturry Double yellow lines

Beech Avenue & Updown Way, Chartham

Double yellow lines

Old Church Way, Chartham Double yellow lines

The order was made on 25th July 2013 and comes into force on 29th July 2013. Full details are contained in the Order which, together with a Statement of the Council's reasons for making the Order and a copy of the orders amended by the Order may be examined at the Canterbury City Council offices, Military Road, Canterbury, CT1 1YW during normal office hours.

Any person wishing to question the validity of the Order or any of the provisions contained therein on the grounds that it is not within the powers of the relevant enabling Act or that any requirement of any such enabling Act or of any regulations made thereunder have not been complied with may within 6 weeks from the date on which the Order was made make application to the High Court for this purpose.

The Council of the County of Kent in exercise of their powers under sections 1(1), 2(1) to (3), 3(2), 4(1) and 4(2), 32(1), 35(1), 45, 46, 49 and 53 of the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the chief officer of police in accordance with Paragraph 20 of Schedule 9 to the Act, hereby make the following Order:

A - This Order may be cited as the Kent County Council (Canterbury Rural Parishes) (Traffic Regulation and Street Parking Places) (Amendment No. 2a) Order 2013 and shall come into operation on the 29th July 2013.

B - Kent County Council (Canterbury Rural Parishes) (Traffic Regulation and Street Parking Places) (Consolidation) Order 2012 shall have effect as though:

In the Schedules to the Order:

Roads in the Parish of Chartham

BEECH AVENUE

The following to be inserted in the First Schedule –

BEECH AVENUE On the southern side, for 14 metres either side of the junction with Updown Way

OLD CHURCH WAY

The following to be inserted in the First Schedule -

OLD CHURCH WAY

On the eastern side, between the junctions with Beech Avenue and Godfrey Gardens

UPDOWN WAY

The following to be inserted in the First Schedule -

UPDOWN WAY on both sides, for 14 metres from the junction with Beech

Avenue

Roads in the Parish of Sturry

RISDON CLOSE

The following to be inserted in the First Schedule -

RISDON CLOSE

from a point in line with the boundary of 7 & 8 Risdon Close to 4 metres south-west of a point in line with the north-eastern flank wall of 9 Risdon Close
