# THE KENT COUNTY COUNCIL (CANTERBURY) (TRAFFIC REGULATION AND STREET PARKING PLACES) (AMENDMENT No. 1) ORDER 2014

The Council of the County of Kent in exercise of their powers under sections 1(1), 2(1) to (3), 3(2), 4(1) and 4(2), 32(1), 35(1), 45, 46, 49 and 53 of the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the chief officer of police in accordance with Paragraph 20 of Schedule 9 to the Act, hereby make the following Order:

- A This Order may be cited as the Kent County Council (Canterbury) (Traffic Regulation and Street Parking Places) (Amendment No. 1) Order 2014 and shall come into operation on the 28<sup>th</sup> February 2014.
- B Kent County Council (Canterbury) (Traffic Regulation and Street Parking Places) (Consolidation) Order 2013 shall have effect as though:

# In the Schedules to the Order:

### **BISHOPS WAY**

The following to be added to the First Schedule in place of the existing entry -

**BISHOPS WAY** 

- (1) On both sides
- (a) between points 10 metres west of the junction with Davidson Road and 10 metres east of the junction with Temple Road:
- (b) from the junction with Fisher Road for a distance of 14 metres in an easterly direction
- (c) from a point in line with the north-eastern flank wall of 1 & 17 Joseph Conrad House for 24 metres in an north-easterly direction.

# **FARLEIGH ROAD**

The following to be added to the First Schedule in place of the existing entry -

FARLEIGH ROAD On both sides for the entire length

#### FRANKLYN ROAD

The following to be added to the First Schedule in place of the existing entry -

FRANKLYN ROAD

- (1) On the western side from the junction with Knight Avenue to the common boundary of 4 and 6 Franklyn Road.
- (2) On the eastern side between points 10 metres north and 14 metres south of the junction with Pardoner Close

# **HILLSIDE AVENUE**

The following to be added to the First Schedule in place of the existing entry -

HILLSIDE AVENUE

- (1) On the south-eastern side from a point in line with the common boundary of 6 and 8 Hillside Avenue to a point in line with the common boundary of 12 and 14 Hillside Avenue
- (2) On the north-western side from a point in line with the common boundary of 24 and 26 Hillside Avenue to 13 metres north-east of the junction with Meadow Road

# **MEADOW ROAD**

The following to be added to the First Schedule -

MEADOW ROAD

On both sides for 14 metres from the junction with Hillside Avenue

# PARDONER CLOSE

The following to be added to the First Schedule -

PARDONER CLOSE

- (1) On the northern side for 14 metres from the junction with Franklyn Road
- (2) On the southern side for 22 metres from the junction with Franklyn Road
