THE COUNTY COUNCIL OF THE CITY AND COUNTY OF CARDIFF (BUS LANES) (CONSOLIDATION) TRAFFIC ORDER 2014

1. The County Council of the City and County of Cardiff in exercise of its powers under Sections 1(1) and 2(1) to (3) of the Road Traffic Regulation Act 1984, ("the Act"), Part 6 of the Traffic Management Act 2004 ("the 2004 Act"), The Civil Enforcement of Road Traffic Contraventions (General Provisions) (Wales) Regulations 2013, The Civil Enforcement of Bus Lane and Moving Traffic Contraventions (City and County of Cardiff) Designation Order 2014 and of all other powers enabling it in that behalf and after consultation with the Chief Constable, South Wales Police, in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

PART I - PRELIMINARY

Definitions.

In this Order the following expressions shall have the meanings hereby respectively assigned to them unless the context of their use requires otherwise:

"the 1984 Act" means the Road Traffic Regulation Act 1984;

"the 2004 Act" means the Traffic Management Act 2004;

"the 2013 Regulations" means the Civil Enforcement of Road Traffic Contraventions (General Provisions) (Wales) Regulations 2013;

"Bus Lane" means any area which is bounded on one side by the edge of the carriageway and on the other side by a white line marked on the carriageway or by a white line marked on both sides of the bus lane;

"The Council" means the County Council of the City and County of Cardiff or its predecessors and/or its duly authorised agents;

"Civil Enforcement Officer" has the meaning given by section 76 of the 2004 Act and means a person authorised by or on behalf of the Council to supervise and enforce Road Traffic Contraventions;

"Enactment" means any enactment whether public general or local and includes any order, byelaw, regulation, rule or scheme or other instrument having effect by virtue of an enactment;

"Public Service Vehicle" means a motor vehicle (other than a tramcar) which is:-

- (a) being a vehicle adapted to carry more than eight passengers, is being used for carrying passengers for hire or reward; or
- (b) being a vehicle not so adapted, is used for carrying passengers for hire or reward at separate fares in the course of a business of carrying passengers

"Licensed Hackney Carriage" shall have the same meaning as defined by Section 38(1) of the Vehicles (Excise) Act 1971.

"Schedule" without more means a Schedule to this Order;

PART II – GENERAL

- 3. No person shall except upon the direction or with the permission of a police constable in uniform or a traffic warden cause or permit any vehicle to proceed within a marked "Bus Lane" being an area which is bounded on one side by the edge of the carriageway and on the other side by a white line marked on the carriageway or by a white line marked on both sides of the bus lane in the lengths of road specified in Schedule 1 to this Order.
- 4. No person shall except upon the direction or with the permission of a police constable in uniform or a Civil Enforcement Officer cause or permit any vehicle to wait at any time in the Bus Lanes specified in Schedule 1 to this Order.

PART III – EXEMPTIONS

- 5. Article 3 of this Order shall not render it unlawful:
 - (i) to cause or permit a Public Service Vehicle or a Licensed Hackney Carriage to use or proceed along the Bus Lane; or
 - (ii) to cause or permit any pedal cycle to use or proceed along the Bus Lane.
- 6. Articles 3 of this Order shall not render it unlawful to cause or permit a vehicle to proceed in any of the lengths of road so referred to for as long as may be necessary:-
 - (a) to enable a vehicle to be used in any of the lengths of road for as long as may be necessary to enable it to be used for any of the following purposes if it cannot conveniently be used for such purpose in any other road:-
 - (i) in connection with any building operation or demolition;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance improvement or reconstruction of any part or parts of the said length of road referred to; or
 - (iv) the laying erection alteration or repair in or near to any of the lengths of road of any sewer or of any main pipe or apparatus for the supply of gas water or electricity or of any telecommunication apparatus pursuant to Schedule 9 of the Telecommunications Act 1984 (as amended) or the placing, maintenance or removal of any traffic sign.

- (b) where the vehicle is being used for the collection of refuse from premises adjacent to that length of road or only accessible there from.
- (c) where the vehicle is being used in pursuant of its statutory duties and in particular but without prejudice to the generality of the foregoing to enable vehicles to be used for police, ambulance and fire brigade services.
- where the vehicle is being used in connection with the maintenance, repair, replacement or improvement of any street furniture.
 - (e) where the vehicle is being used in connection with the maintenance, repair, laying, erection or alteration in or adjacent to the street of any pipe, main or apparatus for the supply of gas, electricity, water or any electronic communications apparatus as defined by the Communications Act 2003.
 - (f) Where the vehicle is being used for the repair of a Public Service Vehicle.
- 7. Articles 4 of this Order shall not render it unlawful to cause or permit a vehicle to wait in any of the lengths of road so referred to for as long as may be necessary:-
 - (a) to enable persons to board or alight from a vehicle;
 - (b) to enable goods to be loaded onto or unloaded from a vehicle subject to the timing of any loading restriction applicable at that place.
 - (c) to enable a vehicle to be used in any of the lengths of road for as long as may be necessary to enable it to be used for any of the following purposes if it cannot conveniently be used for such purpose in any other road:-
 - (i) in connection with any building operation or demolition;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance improvement or reconstruction of any part or parts of the said length of road to; or
 - (iv) the laying erection alteration or repair in or near to any of the lengths of road of any sewer or of any main pipe or apparatus for the supply of gas water or electricity or of any telecommunication apparatus pursuant to Schedule 9 of the Telecommunications Act 1984 (as amended) or the placing, maintenance or removal of any traffic sign.

- (d) where the vehicle is being used for the collection of refuse from premises adjacent to that length of road or only accessible there from.
- (e) where the vehicle is being used in pursuant of its statutory duties and in particular but without prejudice to the generality of the foregoing to enable vehicles to be used for police ambulance and fire brigade services.
- (f) where the vehicle is being used in connection with the maintenance, repair, replacement or improvement of any street furniture.
- (g) where the vehicle is being used in connection with the maintenance, repair, laying, erection or alteration in or adjacent to the street of any pipe, main or apparatus for the supply of gas, electricity, water or any electronic communications apparatus as defined by the Communications Act 2003.
- (h) as part of a funeral cortege or otherwise in connection with a funeral provided the vehicle is owned by a funeral director or by an owner of funeral vehicles.
- (i) Where the vehicle is being used for the repair of a Public Service Vehicle.
- (k) where the vehicle is being used for the collection of mail from Royal Mail post boxes adjacent to that length of road or only accessible there from.
- 8. The restrictions in Articles 3 and 4 of this Order shall not apply if:
 - (a) The vehicle is in the bus lane only to such extent and for so long as it is necessary to enter or exit a side road or for it to access or leave premises adjacent to the bus lane.
 - (b) The vehicle is in the bus lane in circumstances beyond the reasonable control of the driver or in order to avoid an accident.
 - (c) The vehicle is in the bus lane only to such extent and for so long as it is necessary to comply with any requirement resulting from street works or an emergency in any part of the road adjacent to the bus lane.
 - (d) The vehicle is in the bus lane with the permission of the Council or a police constable or civil enforcement officer in uniform.

PART IV - CONTRAVENTIONS

9. Save as provided in Articles 5, 6, 7 & 8 of this Order, if a vehicle is observed by a Civil Enforcement Officer in a length of Road defined in Schedule 1 during the permitted hours or prescribed time without complying with the provisions of this

- Order, a contravention shall be deemed to have occurred and a Penalty Charge shall be payable.
- 10. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into force of this Order, the orders listed in Schedule 2 to this Order are hereby revoked and the orders listed in Schedule 3 to this Order are revoked in part as specified in the said Schedule 3.
- 11. The restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulation made or having effect as if made under "the Act" or by or under any other enactment.
- 12. Reference to any statutory provision includes reference to any amendment, substitution or re-enactment of that statutory provision for the time being in force.
- 13. The Interpretation Act 1978 shall apply to this Order as it applied to an Act of Parliament.
- 14. If any provision of this Order is held invalid or unenforceable for any reason by a court of competent jurisdiction such provision shall be severed and the remainder of the provisions of the Order shall continue in full force and effect as if the Order had been executed with the invalid illegal or unenforceable provision eliminated.
- 15. In this Order, except when the context otherwise requires, the singular includes the plural and vice versa.
- 16. This Order shall come into operation on the 28th November 2014 and may be cited as "The County Council of the City and County of Cardiff (Bus Lanes) (Consolidation) Order 2014".
