

THE COUNCIL OF THE CITY OF CARLISLE

(OFF STREET PARKING PLACES) (VARIATION) ORDER 2004

The Council of the City of Carlisle (hereinafter referred to as "the Council" in exercise of the powers under Sections 32 and 35 of the Road Traffic Regulation Act 1984 ("the Act") and of Part IV of Schedule 9 to the Act and of all other enabling powers and with the consent of the Council of the County of Cumbria given under Section 39(3) of the Act and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

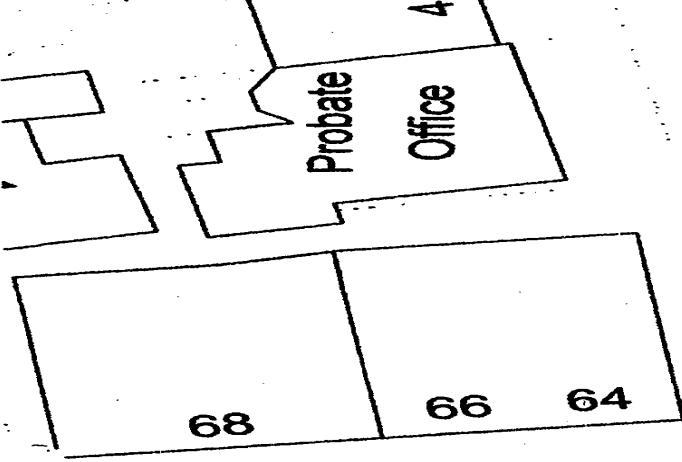
1. The City of Carlisle (Off Street Parking Places) Order 2001 ("the Order") is hereby amended as follows:
 - 1.1 The words "or side" are deleted from the definition of "Appropriate Manner" at Article 1.01 (a) of the Order.
 - 1.2 The expression "Director of Environment and Development" is substituted by "Head of Commercial and Technical Services" at Article 1.08, 1.35, 7, 16 and 31 of the Order.
 - 1.3 The words "and from the front of" are inserted between the words "outside" and "the" on the four occasions where the said two words occur juxtaposed in Article 1.31 of the Order.
 - 1.4 The word "permit" is substituted for the word "badge" where it occurs in the heading expression "in the case of any other badge as follows" at Article 1.31 of the Order and also where it occurs at Article 1.31(i) and 1.31(ii) in the text under the said heading expression.
 - 1.5 The definition of Residents Parking Permit at Article 1.32 of the Order is amended to the following :

"Residents Parking Permit" means a non transferable permit for a specified vehicle for residents business users or visitors who live work or are staying in the vicinity of the car park for the parking of a motor car in residents' car parking spaces belonging to the Council improper use of which will render the permit void.
 - 1.6 At Article 21 of the Order the expression "Appropriate Manner" is substituted for the expression "Relevant Position".
 - 1.7 At Article 23(2) of the Order the requirement at (c) for "Colour of Vehicle" as part of the particulars for the Penalty Charge Notice is deleted.

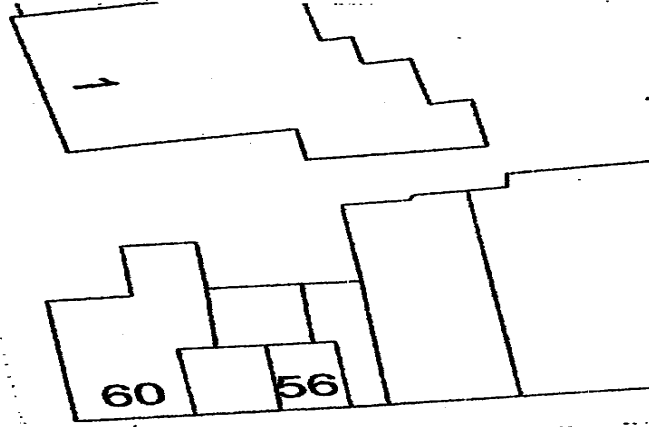
- 1.8 The expression "the City Treasurer" at Article 23(3) of the Order is deleted.
- 1.9 The expressions "the City Treasurer", "the City Treasurer's Department" and "the said Department" where they occur at Article 23(4) of the Order shall each be substituted by the expression "the Council".
- 1.10 At Article 25 of the Order the expression "Relevant Position" shall be substituted for the expression "Appropriate Manner" whenever it occurs at (a) (b) and (c).
- 1.11 Under the First Schedule of the Order there are added the following Parking Places:

- 1.12.1 Packhorse Yard Loading Bays (as shown edged red on Plan A attached to this Order).
- 1.12.2 Old Bush Yard Loading Bays (as shown edged red on Plan B attached to this Order).

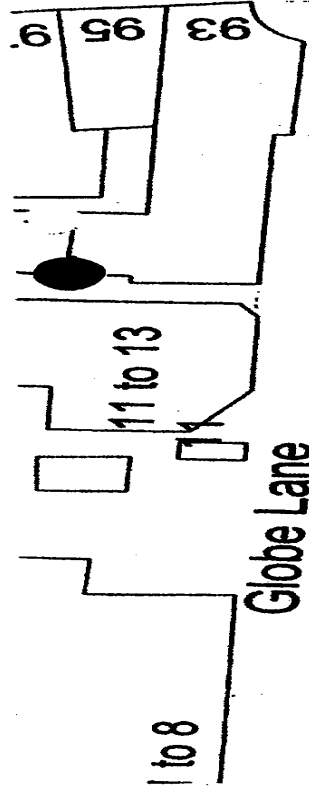
OLD BUSH YARD CAR PARKING

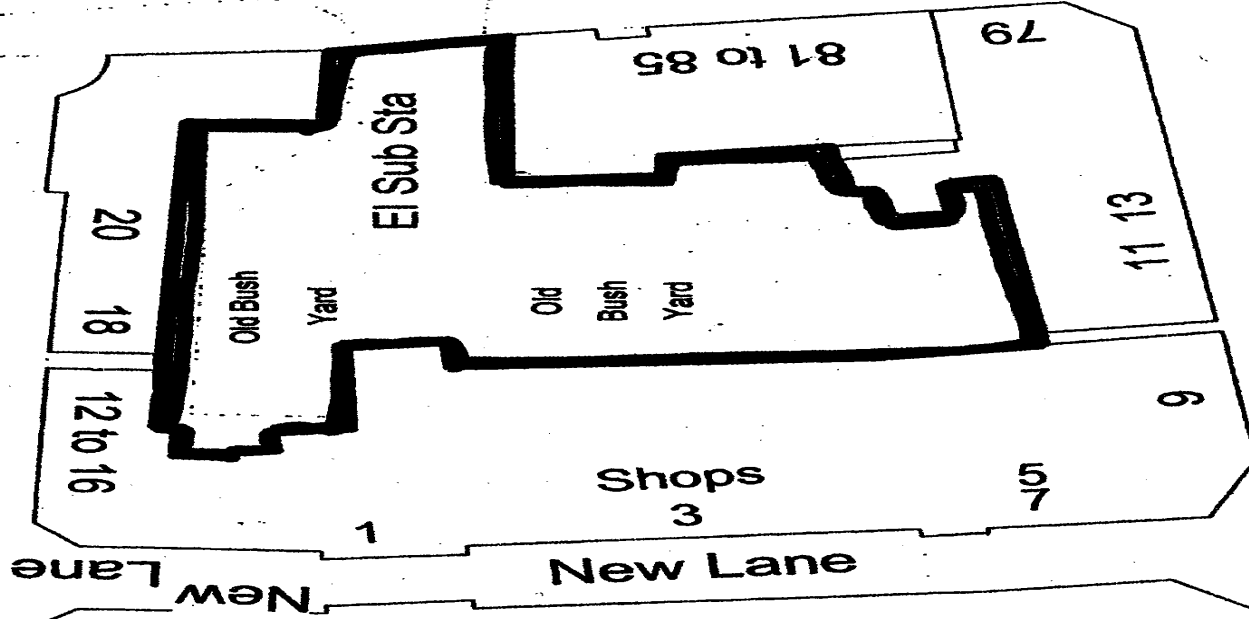

1.14 Under the category of Free Parking Places listed in Part III of the Second Schedule to the Order there are added the following areas of land:

1.14.1 Bousteads Grassing (as shown edged red on Plan C attached to this Order).

1.15 The classification of The Sands as a Long Stay Car Park incurring Long Stay fees in the Second Schedule and Part II of the Order is cancelled.

1.16 There is added to the Second Schedule and Part I of the Order the Sands as a Short Stay Car Park incurring short stay fees as follows:

1.17 The Sands is cancelled from the list of car parks specified in Part V – Contract Parking Permits of the Order

2. This Order shall come into operation on 1 April 2004 and may be cited as "The City of Carlisle (Off Street Parking Places) (Variation) Order 2004."
