(OFF STREET PARKING PLACES) (CONSOLIDATION AND MINOR AMENDMENT VARIATION PAY BY TELEPHONE) ORDER 2012 (VARIATION NO. 2: RENAMING AND CHARGEABLE HOURS RESCHEDULING) ORDER 2016

The City Council of Carlisle (also known as the Council of the City of Carlisle) (hereinafter referred to as "the Council") in exercise of the powers under Sections 32 and 35 of the Road Traffic Regulation Act 1984 ("The Act") and of part IV of Schedule 9 to the Act and under Part 6 and Schedules 8 & 9 of the Traffic Management Act 2004 and of all other enabling powers and with the consent of the Council of the County of Cumbria given under Section 39(3) of the Act and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of The Act hereby makes the following Order.

1. The Council of the City of Carlisle (Off Street Parking Places) (Consolidation and Minor Amendment Variation – Pay by Telephone) Order 2012 ("the Order") is hereby further amended as follows:
2. Under Schedule 3 of the Order the following Pay and Display Parking Places are renamed as appears in the table below:

Devonshire Walk Car Park	Castle Car Park
Town Dyke Orchard Car Park	West Walls Car Park
Upper Viaduct Car Park	Viaduct Car Park
Lower Viaduct Car Park	Caldew Riverside Car Park
West Walls Car Park	Marks and Spencer Car Park

3. Under Schedule 3 of the Order the plans of Pay and Display Parking Places at Devonshire Walk Car Park, Town Dyke Orchard Car Park, Upper Viaduct Car Park, Lower Viaduct Car Park and West Walls/ Marks and Spencer Car Park are removed and replaced by the updated plans annexed hereto and marked respectively Castle Car Park, West Walls Car Park, Viaduct Car Park, Caldew Riverside Car Park and Marks and Spencer Car Park
4. In Schedule 3 'Off Street Pay and Display Parking Places' the Cecil Street car park table and plan of Cecil Street Car Park is removed from the Schedule

and the Order shall be read and construed as though Cecil Street Car Park had not been included and referred to in the Order.

5. Under Schedule 9 of the Order the Marks and Spencer Car Park table is amended as follows:

Monday to Saturday between 8.00am and 7.00 pm Sunday between 10:00am and 5.00pm	Marks and Spencer	21	Up to 1 hour £1:00 1-2 hours £2.00

6. This Order shall come into operation on 6th January 2017 and may be cited as "The City Council of Carlisle (Off Street Parking Places) (Consolidation and Minor Amendment Variation Pay by Telephone) Order 2012. (Variation No 2: Renaming and Chargeable Hours Rescheduling) Order 2016".

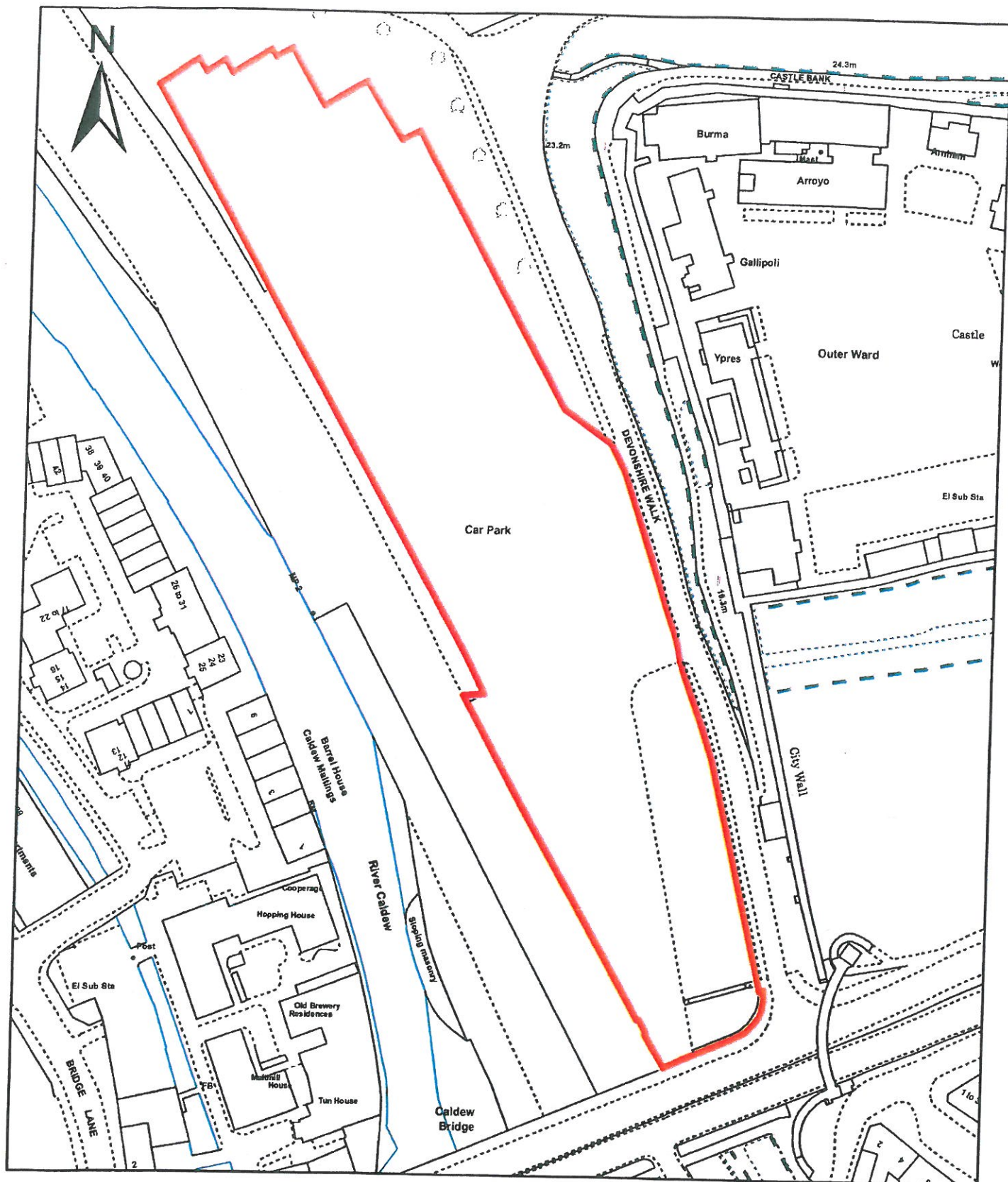

Carlisle City Council considers that it is expedient to make the above Order for the following reasons:

1. Castle Car Park, West Walls Car Park, Viaduct Car Park, Caldew Riverside Car Park and Marks and Spencer Car Park are renamed as such because these names are deemed most appropriate to clarify their location in the city of Carlisle for the benefit of visitors.
2. Marks and Spencer as freehold owner of the Marks and Spencer Car Park have elected to revise their car park chargeable hours to be more aligned with their store trading hours.
3. Cecil Street Car Park is removed from the above Order because primary control and operation of the Cecil Street Car Park facility is scheduled to pass from Carlisle City Council to Cumbria County Council as freehold owner of the land on which the Car Park is situated with effect from 6th January 2017.

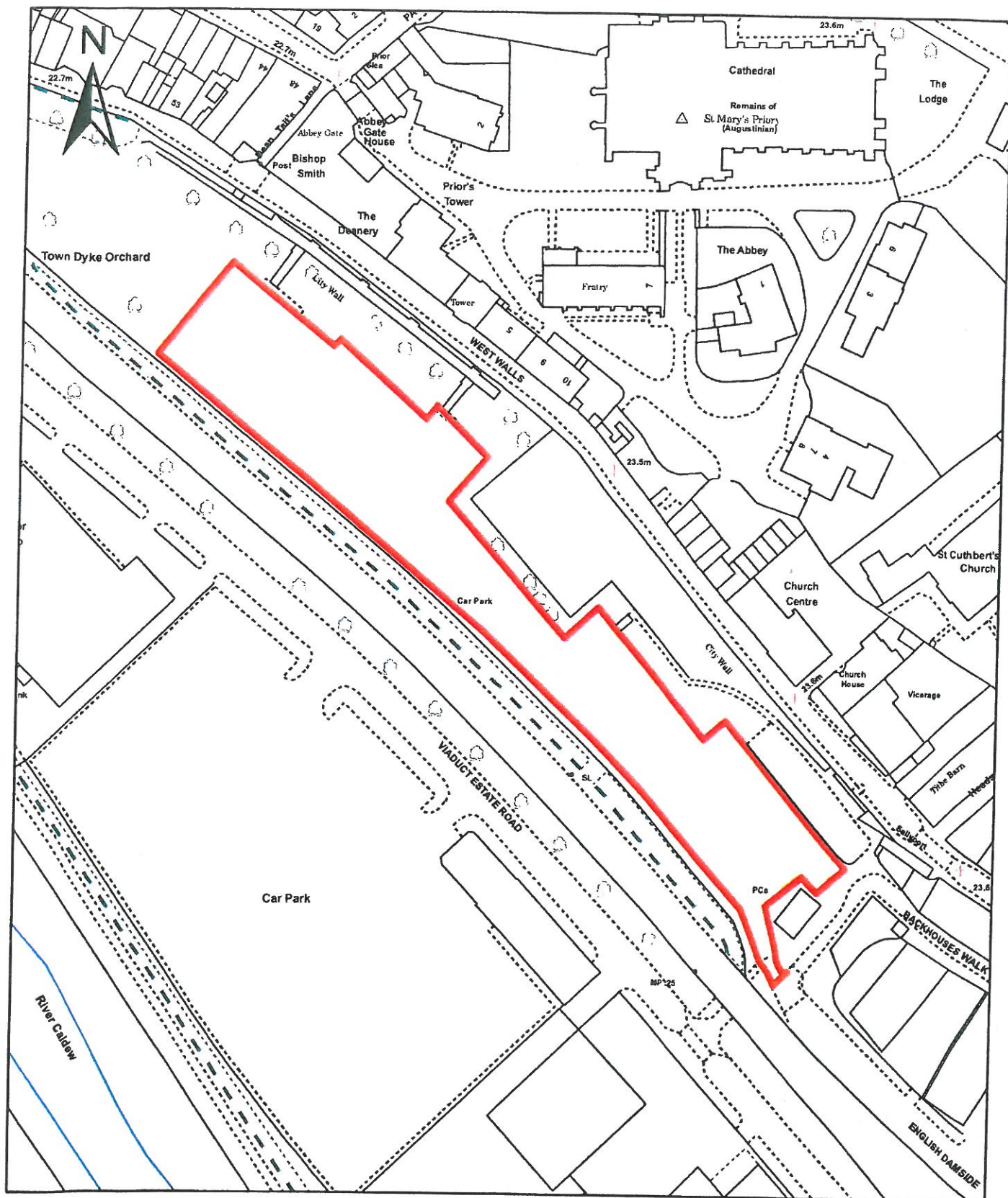

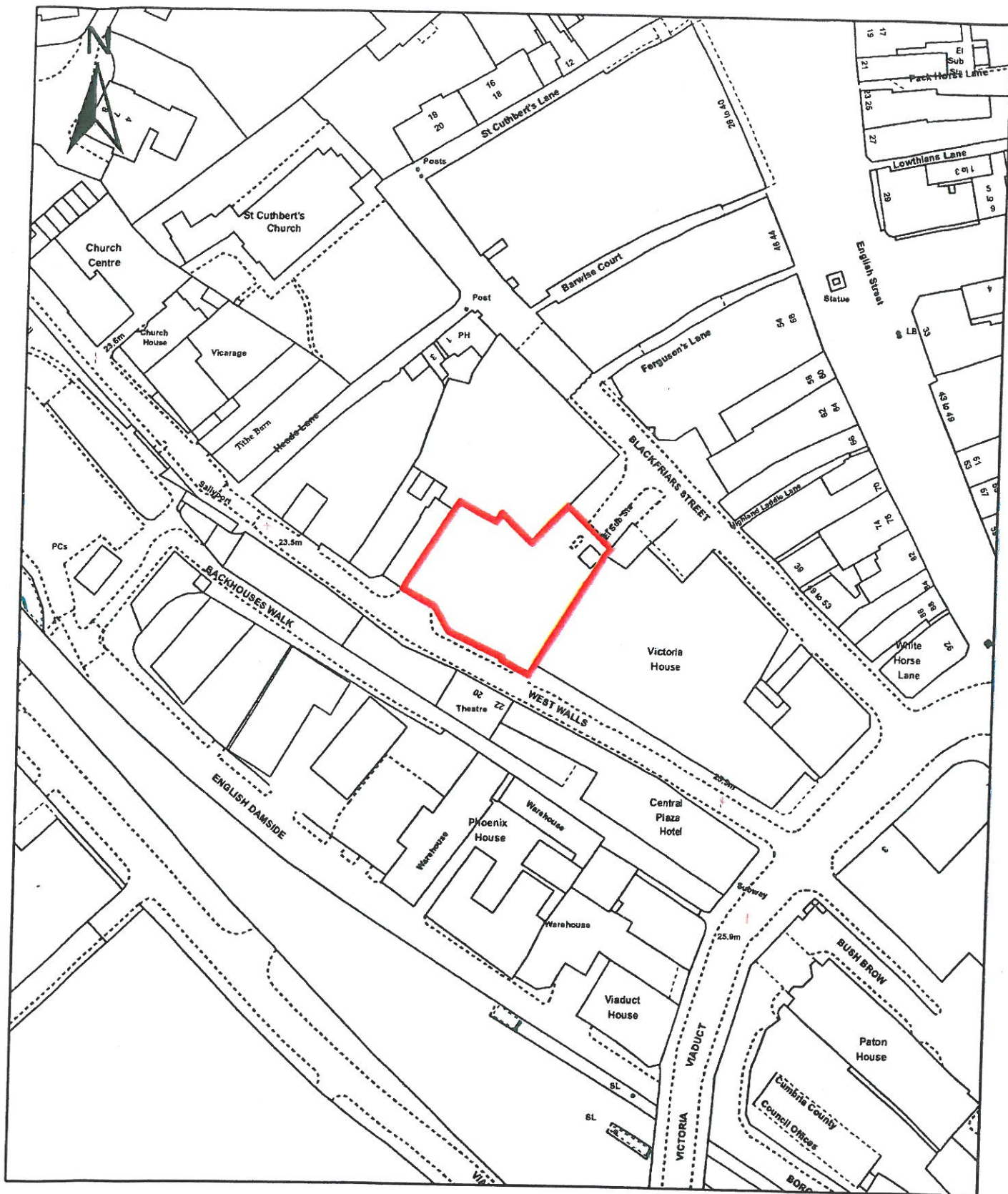

MARKS & SPENCER PAY AND DISPLAY CAR PARK

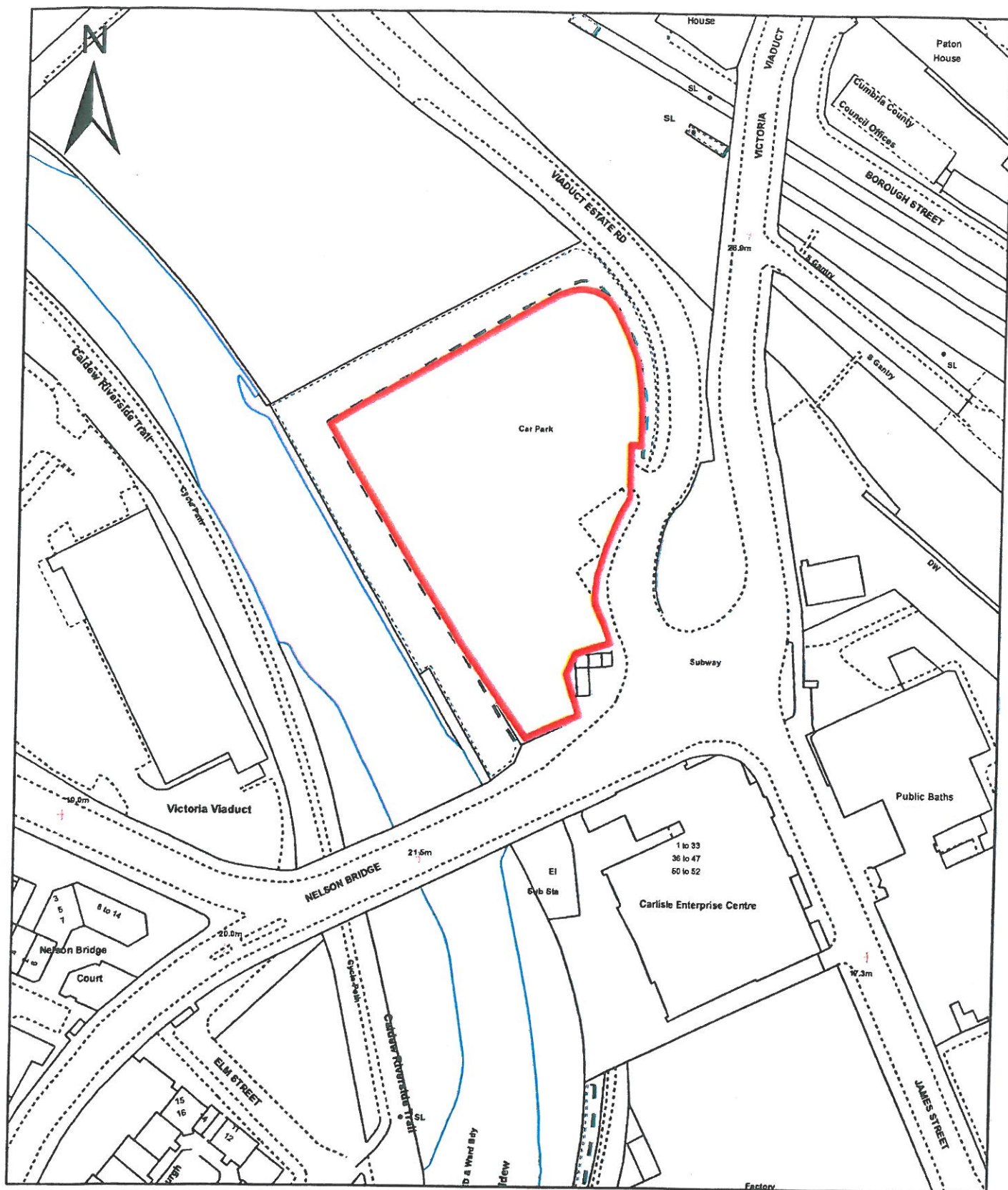

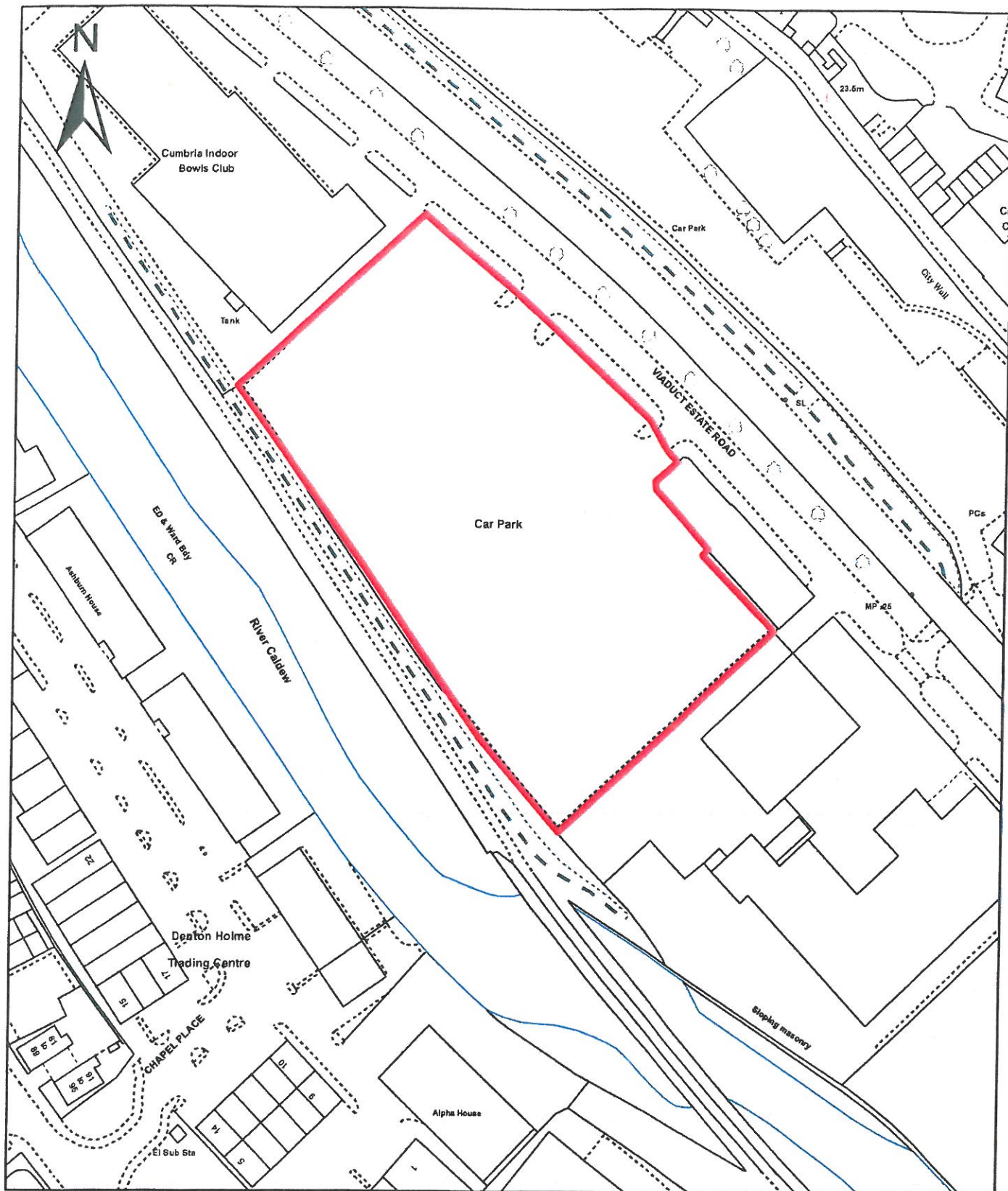
VIADUCT PAY AND DISPLAY CAR PARK
